From our NATIONAL CHAIRMAN

A NEW JESUS' MOVEMENT

I was saved in 1971 during the Jesus *movement* when millions of young people were impacted with the good news about Jesus. It was a time of great social and cultural upheaval in the western world, and I'm expecting another similar revival to sweep Australia and the world. This year's fabulous film 'The Jesus Revolution' accurately portrayed this unique move of God. It brought tears to my eyes as I experienced this in Adelaide as a 17 year old kid.

Culturally and socially we are becoming even more fractured than the late 1960's/ early 1970's. People are rapidly losing hope, as mistrust in society's institutions is growing at an alarming rate. I sense we are ripe for a new Jesus awakening and the CRC is preparing itself to be at the forefront of a new salvation move, especially among our youth and young adults.

THE NEXT CHAPTER

What an appropriate theme for our 2023 CRC National Conference where we are releasing our next 5yr strategic plan (2023-2028). Revival is at the heart of our spiritual plans.

The prayerful process we have undertaken to frame these Strategic Directions after surveying all our pastors, keeps us aligned to our changeless vision and enduring values.

They prevent us being diverted to lesser things which take our eyes off the main game.

The CRC is a New Testament movement and we are careful to stay Biblically grounded, Cross focussed, Christ centred, Holy Spirit led, prayerfully

dependent, people loving, culture changing, forward moving (in faith & obedience) and outreach orientated. To shift from these foundations makes us spiritually powerless and we will miss out on the revival Jesus has in mind.

I have encountered 20 distracting theological heresies and extreme ministry emphases over the past half century of ministry and church leadership. They all get our eyes off propagating Jesus' gospel and outworking Jesus' Great Commandment and Great Commission. These return from time to time in Australia and across the world. I've just returned from Ghana and Greece where the 'prosperity gospel', 'hyper faith', 'legalism', 'false prophets' and 'anti women in ministry' etc. are confusing people about what the true gospel of grace is all about. These and other false views that caricature the gospel will cause many to lose their spiritual effectiveness.

I'm so concerned Jesus' Church is not beguiled and diverted from the main game, that I've written my latest book Biblical Stability In Uncertain Times to address this phenomenon. I pray it will be a helpful tool for pastors and churches to stay fully aligned to the New Testament pattern for revival in our time.

WORLDWIDE PENTECOSTAL REVIVAL

It was an honour to represent the CRC at the triennial World Pentecostal *Conference* in Seoul, South Korea last October, and to be appointed to the 30 member Advisory Council, representing Australia. We are part of the 650 million Pentecostals across the globe, and it's reassuring we are part of the fastest growing Christian movement in the world.

I also attended as a Board member of the *Healing Jesus Campaigns* a unique gathering in Accra Ghana in late July. This evangelistic outreach ministry by Bishop Dag Heward-Mills has led over 15 million people to Jesus. *The LightHouse Chapel International* movement started in 1988 by Bishop Dag as a young medical doctor has now planted over 6,000 new churches.

Across Africa, Asia, Central & South America this pattern is being repeated. The western world nations are the only exception to this and we are all working to reverse this downward trend.

The National Church Life Survey (NCLS) research group has reaffirmed from its first survey in 1991, it's the evangelical and Pentecostal churches that are growing in Australia.

Closer to home it was my privilege to visit PNG in May to spend time with the CRC's National Executive Council (around 50 key Pastors from all the provinces make up the NEC), and to minister at Bethel Centre, Port Moresby. I've been visiting PNG most years since 1987, so it was a particular delight to see my brother and sister pastors after a 4 year break due to COVID. We have over 500 churches and outreaches across PNG which makes it our largest CRC Nation, and it's always a delight to have some of our PNG leaders with us at our National Conferences.

ORGANISATIONAL MATTERS

Government Regulations

We are so pleased that Pastor Wendy Brooks is continuing employment two days a week as our national staff member overseeing the many 'government regulations' we all must comply with.

She is a wonderful woman of God and is such a gift to our movement.

Credential Process

We have improved the process for people starting on the credential pathway.

FROM OUR **NATIONAL** CHAIRMAN

There have been some sensitive issues that arise from receiving applications and references just before a credential interview and after the respective competencies have been completed.

To help avoid these issues, we have made a timely and important change. All credential applications and references are now being sent to the State Credential teams by the nominating ministers and local churches at the beginning of the process, and before coaches start working through the competencies with the candidates.

Pastoral Supervision

This is a recommendation by the Royal Commission into Institutional Abuse of Children held several years ago. Its purpose is to ensure all Pastors have a supervisor who can provide personal support and encouragement in outworking their ministry call.

Most professional counsellors and other intensive people helping vocations already have a similar measure in place. We now have a plan to provide training for this positive initiative, as we anticipate our governments will eventually make this a legal requirement for Pastors. We will be rolling this out over a 5 year process.

WORKING TEAMS

To implement our Strategic Directions, we are putting together some Working Groups led by National Executive members and other experienced Pastors. I am so pleased the Lord is raising up some highly competent and character filled leaders across our movement. Each team leader who is sharing at Conference will have a group of gifted pastors & leaders from each State helping them facilitate their portfolio.

VOICE REFERENDUM

I have written an extensive letter to all our pastors, delegates & churches expressing my thoughts, and it's available on our CRC Website.

I concluded with the following:

"I never publicly state my voting intentions in elections and neither will I about this referendum. Nor do I ever use the pulpit to encourage my congregation to vote a particular way or support a political party. I encourage you to do the same. Hopefully my thoughts are helpful as you read, reflect and pray about this important civic duty we must embrace as Christians.

Finally let's not get diverted as churches and Christ followers by political, social and racial divisions which easily get inflamed. Don't get pulled to the left or right of our world's politics, just go deeper in Jesus and His cause. We are all called and commissioned by Jesus to proclaim His good news about salvation, to lead people to Christ and connect them into existing or new churches. We all know it is an encounter with Jesus that ultimately changes lives, restores the broken, heals relationships, breaks addiction and releases us from guilt, shame and fear. Let's never forget we are Just beggars showing another beggar where to find bread.

Reconciliation and peace between people and social groups naturally flows when we are reconciled to our amazingly loving, forgiving and restoring Heavenly Father. Peace with God through personal faith in Jesus (Romans 5:1) causes the peace of God to heal our souls (Philippians 4:7) and becomes the enduring basis to bring peace between people (Ephesians 2:14-18). This is the priceless Gospel we steward and it's the only lasting Hope for our broken world.

This year's National Conference will provide an opportunity to collectively pray for unity and peace in our beloved nation at this historic juncture, and for our precious Aboriginal and Torres Strait Islander peoples."

There was a bit of change around the states this year, some planned, some sad, and some surprising. New leadership at the Tea Tree Gully church under Pastor Rodney Garland is going very well. MISSIONS

The past year has been a time for churches to get back to the 'new normal' following the upheaval of the pandemic.

People are moving out again on Mission Trips. Pulse Magazine this year is focusing on Missionaries and Mission Trips, as there is plenty happening.

International Vision

To fulfil our International Vision of a presence in every nation by 2045 we need to be clearly focused beyond our own backyard.

In 2014 there were 37 nations regularly visited, and we had contact with a total of 65 nations. In 2023 this has increased to 61 nations regularly visited (increase of 65%), and a total of 77 nations contacted (increase of 21%). We are making good steady progress!

The best estimate we have available is that those nations regularly visited would equate to a realistic presence in that nation. From these statistics the focus appears to have been more on our established fields which was probably needed after the pandemic, but it now needs to expand and start to open more nations as is happening in Africa.

We are making progress in the Pacific, Asia, and Africa, but we also need a major thrust in Europe and the Americas – North and South. Our International Vision will be easily fulfilled if all our existing nations reach out to another nation every 5 -10 years. This would mean a considerable stretching of our resources, but God will only give us more resources as we are making full use of those we already have.

Training

The CRC IMBC (International Missions Bible College) in Africa has now had 2,510 students registered.

Those graduated are:

This year (2023) there are 1151 people being trained.

The feedback on the students is that the courses are making a major impact on the quality of ministry and personal and spiritual growth.

This year there are IMBC Campuses in 15 nations in Africa. In 2024 it is expected that another 10 nations will be included, and the courses will be available in 7 languages.

Day of Prayer

This was held on Thursday 27th July 2023 with a total of 40 Australian churches involved.

The past year has been a time for churches to get back to the 'new normal' following the upheaval of the pandemic.

Missions Sunday

This was Sunday 30th July 2023 with a total of 43 Australian churches involved. An offering was received from 33 churches. So far \$41,977 has been received at our Missions Office for the Training Centre in Mwanza, Tanzania.

MISSIONS

It is encouraging to write about the work that the Spirt of God is doing in the nations and within our own nation of Australia.

Spontaneity in Evangelism

In a number of nations, I am seeing what I call "ground swell" of enthusiasm and excitement arising amongst youth as they spontaneously group themselves together and venture into rural areas, villages, towns, and displaced persons settlements preaching and witnessing through street evangelism, open air meetings, crusades and home gatherings. They are seeing people coming to Christ, baptized in water and the Spirit, healed and delivered.

Advances in Training

It is refreshing to see an emphasis on training people of all ages that are keen to study God's Word and better prepare themselves for ministry. There is definitely a greater focus on training nationally in a number of countries but I am also seeing this amongst smaller churches who are now taking steps to initiate local church training programs. Training is where our future leadership and ministry lies, with the development of training in Africa, Philippines, PNG and with some other ministries in Sri Lanka and India.

For example, PNG has launched a teaching program called "Walkabout Bible School" which is designed to take teachers to the people who cannot come to the training. The responsiveness to this program is quite amazing and so refreshing, which has caused a new sense of excitement and eagerness in both the teachers as well as the students. It has great possibilities for it to be transplanted into other nations also.

Ministry to Children

There is a definitely a renewed interest in ministering to children, resulting in a desire to regularly gather them together and have input into their lives in some way. Current programs are being re structured and new ones created to cater for the increasing number of children that are so keen to gather.

This eagerness amongst the children to come together is so refreshing to see because it has not always been that way for a long time. Interest in Early Learning training courses and Pre School Teacher training is attracting International and National students. Sunday schools are growing, with children's weekends and camps drawing children from all parts of the community. There is also a growing awareness to establish permanent Pre Schools or Early Learning training centres in the rural and urban areas.

It is truly a joy and privilege to be able to serve our lord in all kinds of weathers knowing that we are touching and transforming lives in one way or another. It is great to be alive in this day and to show God's Power and Love to this generation.

MISSIONS

The key aim of Pathway to Missions is to encourage, train and prepare Australians for cross cultural ministry. Pathway to Missions exists to ultimately prepare people for missionary service and create a network of like-minded people wanting to serve in the nations. 4 simple steps will help transition people along in their journey of missions...

Step 1

Weekend Seminars (run in each state)

Step 2

One-week Missionary Training Intensive

Step 3

Missionary Exposure (1-3 months long)

Step 4

Further Training at World Missions Faith Training School (WMFTS PNG) or Missionary Service

It has been wonderful to see so many people engaging with the Pathway to Missions seminars. In both the NSW and SA seminars held this year, there was a high proportion of young people in attendance. I believe that there is a growing passion within the youth of the CRC to engage meaningfully with service in the nations. This year there has been 3 people take part in Missionary Exposure (Step 3 of Pathway to Missions). One of these spent a month in the Philippines and had an amazing time. Another one travelled with me to Nepal for 3 weeks, for their first cross cultural missions trip. The third person has been engaged in the Alice Springs church working predominately with Aboriginal ladies.

My desire is to see more people flow into doing cross-culture missions exposure for 1-3 months, this can be tailored to the needs and availability of each individual.

We will be conducting Pathway to Missions Seminars in NSW, Victoria and SA in 2024 and hope to run the second one-week Missionary Training Intensive in July 2023. For more information, please contact me via email steeljeremy0@gmail.com

Key Highlights

This year we set up hubs to allow people from each state to join the Implant Training Day, which has been running in Victoria for many years. Moving forward the Implant Training Day will be rolled out as an in person one-day event in each state, allowing for our Kids, Youth & Young Adults teams to participate nationally.

Report on the Audit of the Financial Report

Opinion

Notes to the Financial Statements For the Year Ended 30th June 2023

Note 1: Summary of Significant Accounting Policies

(a) Basis of Preparation

This special purpose financial report has been prepared for distribution to the members to fulfil the financial reporting requirements under the CRC Churches International Australia Inc constitution and the Australian Charities and Not-for Profits Commission Act 2012. The board has determined that the entity is not a reporting entity.

CRC Churches International Australia Inc is a not-for-profit entity for the purposes of preparing the financial statements.

The financial report, except for the cash flow information, has been prepared on an accruals basis and is based on the historical costs convention. The amounts presented in the financial statements have been rounded to the nearest dollar. The financial statements are presented in Australian dollars, which is the functional currency of the entity.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054: Australian Additional Disclosures.

(b) Income Tax

The entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

(d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(e) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from donors and any outstanding grant receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

(f) Employee Entitlements

Provision is made for the CRC Churches International Australia Inc's liability for employee entitlements arising from services rendered by employees to the end of the reporting year. Employee entitlements expected to be settled within one year, together with entitlements arising from wages & salaries and annual leave, which will be settled after one year, have been measured at their nominal amount. Other employee entitlements payable after one year have been measured at the present value of the estimated future cash flows to be made for those entitlements.

Notes to the Financial Statements cont.

(g) Property, Plant and Equipment

Property, Plant and Equipment are brought to account at cost less, where applicable, any accumulated depreciation.

The carrying amount of Plant, Property and Equipment is reviewed annually by the Board to ensure it is not in excess of the future economic benefit of those assets. Individual items of plant and equipment in excess of \$500, which do not constitute a replacement, are capitalised.

Assets are depreciated on a diminishing value basis and the depreciation rates used for each class of depreciable asset are:

(h) Reserves

Reserves for Future Conferences

Funds have been put aside for use towards the annual national conference, and have been preserved for that purpose.

Missions Resettlement Fund

CRC Missions receive funds which are specifically designated to certain missions. These funds are recorded as revenue when received by CRC Missions and are recorded as an expense when the funds are paid to their designated purpose.

Church Planting Funds Held

Funds that are received for church planting are recorded as income when received and as an expense when paid to their designated purpose. Any remaining funds are preserved until spent.

(i) Revenue Recognition

The entity recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefit will flow to the entity and specific criteria have been met for each activity as discussed below.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

All revenue is stated net of the amount of goods and services tax.

Donations

Donations are recognised as revenue when received.

Grants and Gifts

Minor grants and designated gifts are recognised as revenue when received.

(j) Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

(k) Financial Assets

Financial assets are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the association's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amoritsation process and when the financial asset is derecognised.
