- Our State Chairmen and I are promoting Church Planting across the movement & will be running a new weeklong Church Planting School in January, 2025.

At this year's National Conference our team leaders will take a good look at what Jesus is doing across the CRC and will be sharing on some of the excellent resources from our churches. We desire to disseminate these helpful spiritual and practical tools across our movement.

PNG CELEBRATION

In the first week of July several of our Australian CRC Leaders and I had the privilege of attending the **52nd Anniversary Conference of the CRC in Papua New Guinea**. It was a moving and memorable time with lots of laughs and tears as we celebrated what Jesus has done over the past half century. We have 570 Churches and Outreaches in all 22 provinces of the nation—Praise God.

From PNG, they have reached out to the nations of the Pacific/Asia (ie Solomon Islands, Vanuatu, Fiji, Philippines, Indonesia, Sri Lanka, India, Nepal and other regions of our world). It was a particular joy to connect with some Pastors I hadn't seen for a long time whom I taught in Bible College in the late 1980's/early 1990's. I've been visiting PNG most years since 1987 and it's like a second home to me. I will be returning in mid-October to minister at the School of the Pastor/Teacher in Lae for Lead Pastors as an in-service up-skilling training event. Our aim is to help our pastors to lead and feed their people more effectively.

The entire CRC movement in PNG did a wonderful job of honouring Pastor Barry Silverback, his faithful praying wife Rosalie (who couldn't attend), and the dozens of missionaries from Australia and New Zealand who have served Jesus over the decades with Barry and Rosalie.

How timely it was to raise money in July for our National Missions Offering to renovate the toilet and shower facilities at Bethel Centre, Pt Moresby. At the time of writing this report, \$50,000 has already been received and we expect that to increase as churches continue to send their offerings. What a joy to bless our PNG family with this much needed assistance, so a big thank you to all who contributed.

OPERATIONAL GUIDELINES & GOVERNANCE REGULATIONS

An enormous amount of wise work has been done over the years to help our pastors and churches on a host of matters relating to ministry, leadership and governance. Unfortunately, many of us only refer to them when a problem or crisis occurs to remedy a situation. It's much wiser to be preventative, and as such we are coming up with a workable schedule to re-examine these important spiritual and practical principles with our Church ministry teams and Boards. It may take us a few years to familiarise ourselves with all of them, but we need to build this practise into the organisational life of our churches.

For example, this year we updated our *Women* in *Ministry Guideline*. Several pastors felt we needed to place a biblical rationale to this very short guideline that we put together in the early 1990's. No doubt we will have to update other guidelines, and as you are aware this is continually occurring with the myriad of governance regulations we now have to comply with.

NATIONAL OFFICE STAFF

I am so pleased that Sharon Bradley has joined the team this year as our new General Manager. Sharon is an experienced leader of more than 30 years and brings to the CRC expertise in quality, compliance and systems management. She works for Colour City Church in Orange NSW and Pastor Dan Taylor and his team have generously released Sharon to step into this role. She is employed 2 days per week, working closely with our State Administrator's and Secretaries. Sharon will be working on our Child-Safe records, maintaining our database, helping develop a new CRC website and outwork our strategic directions.

The Communist government of China is on an aggressive warlike pathway across the South China Sea, menacing smaller nations and


threatening to invade Taiwan ... Pray that a change will occur in this dangerous aggressive trajectory of prideful violent confrontation.

A big thanks to all the churches who've hosted these events and specially to Grow Church in St Albans for the way they hosted us all (200+people) at State Conference and helped us all enjoy some wonderful sessions, great food and fellowship over the three days.

The great challenge we've had is seeing more people want to attend some of these events than we could fit into the venues! I believe this is, in part, due to the fact that we have a growing sense of community amongst our churches, with more and more of our congregation members and leaders (not just pastors) wanting to be at conferences. As we continue to strive to see churches planted, nations reached, and people won for Christ, this can only be a good thing -working together as interdependent autonomous local churches.

We have had some wonderful regional gatherings happening all through the year around our States, led by the regional leaders in each area, which also helps grow and strengthen that sense of connection.

State Report SA, NT & WA

Recently I received the honour of welcoming a new church into the CRC. They are a church of Burmese migrants; Chin people who speak the Zomi language ... beautiful people with a passion for Jesus. They wanted to join us because of the culture, vision and values they saw on display in our churches, conferences and organization.

For the welcoming ceremony I was invited to conduct, I decided to preach Pastor Harris' sermon "If I had one sermon to preach". Studying that sermon and presenting it to the people was a great reminder of the heritage of scriptural revelation that our movement has been built on ... timeless truths that still transform us. That new creation message of who we are in Christ still thrives in our core and was received with gratitude by this new church. We have enthusiastically embraced our National Strategic Directions for 2023 to 2028, which was introduced at last year's National Conference, with a view to steadily work through how we can apply the priorities and goals in our State context. Feedback on the current National Strategic Plan has been very positive, with our State pastors and leaders feeling the plan is clear, understandable, achievable, inspirational and focusing on the right Kingdom priorities. Each One ... Teach One, Raise One, Reach One, Connect One and Plant One.

A number of our churches have really appreciated the **Theology Masterclasses**, and we have a few students enrolled in **Revival College** across our States. Many of our churches were also part of the **Implant Training Day**. Check out the Generations and Training reports for more details on these events.

I can once again report with great delight that a definite majority of our State churches are actively involved in supporting significant **Missions** activities overseas and in central Australia. This includes, short and long term missionary service and financial contribution, through both CRC and non-CRC ministries. I could easily write this whole report just about the exciting work taking place through our State CRC churches, but I'll leave that to the informative and inspiring Pulse magazine regularly distributed by our Missions office. I would enthusiastically encourage you to read and distribute each edition as they are sent to each of our pastors and churches throughout the year.

We are blessed to have a gifted and passionate **National Generations Team** available to encourage and equip our CRC churches, both at State and National level, to work towards having vibrant and effective ministries to children, youth and young adults. It's not always easy, but we are committed to doing all we can to assist our State churches in these important and sometimes challenging areas of ministry.

Encounter Youth Camp (formerly known as Condo Camp) is an annual iconic youth event that has been impacting our state youth since 1978, beginning in the central NSW town of Condobolin and more recently hosted in Narrandera for logistical reasons. We had an amazing time this year with the theme "Transformed" and thanks to Beka Dennis and a great team, many young lives experienced exactly that.

We were very excited to have relaunched **Best** is **Better**, our Young adults gathering recently in Sydney with 55 young adults, aged 18 to 30, in attendance. Sam & Tanya Chesser from SA were our amazing guest speakers, beautifully supported by Maika Ravitu and our State Executive team. Thanks again to Beka Dennis and the team for a moving and impacting weekend.

The **Implant** training seminar for kids, youth and young adult ministry leaders, which was successfully birthed by our Victorian CRC churches, is now being made available nationwide. We had hubs in multiple locations across our State this year, with both local and streamed content shared successfully across locations.

Regarding Christian Schools, Verity Christian College (linked to our Lifesource Church in Griffith) have seen their school grow to 143 students plus 12 prep students since commencing in 2018. They recently received full accreditation for teaching Kinder to Year 12, which is a great milestone for the school. Due to significant growth they have plans to establish a separate High School campus in Griffith to enable future expansion. Progress is underway to establish a further campus in Leeton, attached to our Leeton CRC church. Land (approximately 20 acres) has been purchased, and paperwork has been submitted for this faith-filled project. Your prayer support for the next stage of this development would be appreciated.

We have regular **regional gatherings** across the State, including North Queensland, NSW Central Coast, Southern NSW and Sydney. Our heartfelt thanks to Ps Boo who has led the way, faithfully coordinating our Sydney Pastors gatherings for a number of years, with substantial photographic evidence.

Our **State Conference** this year was held in Sydney at the Collaroy Conference Centre. After a few years of our conference being hosted in our regional churches, our State Executive Team felt it was time to head to the city. To simplify accommodation and travel arrangements, and probably more importantly, to foster the growing sense of community and relationship amongst our pastors and leaders, we explored the option of a live-in conference centre, which attracted very positive feedback. The theme "Beloved" was centred around affirming Christ's love for the church as "His Bride" and His Plan A,B & C for reaching our communities and nations with the Gospel. Our guest Pastor Tim O'Neill and our very

own Pastor Dan Parker spoke beautifully to the theme, and the worship and children's programs were a highlight of the time together.

Our passionate and highly competent **State Executive** are such a delight to be a part of, with a genuine heart to serve our CRC family of pastors and churches. They have a strong focus on relationship and for a number of years now have been committed to holding our Executive team meetings, rotating around our CRC locations connecting with our CRC pastors and their teams.

AUSTRALIAN MISSIONS

Over the past year we have seen significant steps towards the fulfilment of our Australian CRC International Vision, of a "Presence in Every Nation by 2045". As we the Australian CRC Churches stand together, we can be an effective part of driving back the powers of darkness and seeing the Gospel continue to break through in all the world. According to our last survey the Australian CRC Churches are involved in over 82 nations (of the 195 in the world), of these, 62 had a regular involvement contributing to an effective disciple making ministry and churches. The remaining nations receive occasional investments of ministry and support.

We have continued to see an ever-enlarging expansion with our International Missions Bible College (IMBC) which is now operating in all continents except Europe and Antarctica in an ever-increasing number of languages. IMBC is being used to equip ministers and leaders for the work of the ministry and as a clear presentation of what the CRC stands for, to those wanting to become part of the CRC global family.

THE CRC 52ND ANNIVERSARY IN PNG

What a great joy it was for the many CRC leaders from so many nations to be able to attend and give honour to the impact that Barry Silverback and the team have had in PNG and now to so many nations of the world. We also had the privilege of officially opening the "Silverback Training Centre" that many of the CRC Churches in Australia contributed to a few years ago with our National Missions Offering.

CRC NATIONAL DAY OF PRAYER / FASTING & NATIONAL MISSIONS DAY

In 2023 we received over \$40,000 towards the building of the Mwanza Tanzania Training Centre. This complex was completed and commissioned in March 2024, and the centre is very active already. Not only

were they able to construct the training area, store area, and trainer accommodation, but they also fundraised extra so that a Church building (complete with chairs and music instruments etc.), youth hall, early learning centre, pastor's accommodation, pastor's office, students' accommodation, kitchens, carpark and security fencing, could all be created on the same site.

In 2024 the National Day of Prayer/Fasting was Thursday 25th July, and the National Missions Day was Sunday 29th July 2024.

The Missions Day offering for 2024 was for the development of the new amenities block located on the original Bethel Centre site, Port Moresby PNG. At the time of writing, offerings are still being received by the Missions Office and the total amount received will be communicated in the coming weeks.

The important dates for 2025 are:

- National Day of Prayer/Fasting Thursday 24th July 2025
- National Missions Day Sunday 28th July 2025

INTERNATIONAL LEADER'S GATHERING (ILG)

Last year we again hosted a ZOOM International Leader's Gathering with many nations joining for a time of CRC family bonding as we shared of what God is doing around the world. In 2024 we will be hosting another ZOOM International Leaders Gathering on Saturday, the 5th of October, following the National Conference. KIDS CAN DO MISSIONS

This 4-week Children's ministry program is a great way to interest kids in global missions. Very soon we will be introducing Kids Can Do Mission "2". Make sure you take the opportunity to use these resources in your children's ministry.

MISSIONARY RESETTLEMENT FUND

We very much appreciate the contribution from churches each year to the Missionary Resettlement Fund, which enables us to provide some funds for long term missionaries who are permanently returning from the field to live in their countries of origin. This offering is taken up at each of our conference or you can directly give via CRC Missions.

FUNDS TRANSFER PLATFORM

With the ever changing government requirement (ACNC External Conduct Standards) we have started using a new funds transfer platform that is between 7-15% better exchange rate than the banks (even after 5% goes to the Missions Office administration), enabling us to transfer funds on behalf of the Australian CRC Churches to over 180 nations. If you would like your missions support to go further, then contact Mikeala Geno to set it up.

COMING EVENTS

At the CRC National Conference, we are hosting a new initiative, the Australian CRC "Global Missions Summit", where we are inviting Australian Senior Ministers and Missions Directors to come together as a way of engaging with our vision to have a "Presence in every nation by 2045". Our first Global Missions Summit will be held on Thursday morning,

the 3rd of October, from 10am to 12pm at Kingston. This will be a time to share experiences, resources, and wisdom on how we can be even more effective in our God-given call to "go and make disciples of all nations, baptizing them in the name of the Father and of the Son and of the Holy Spirit, and teaching them to obey everything I have commanded you" (Matthew 28:19-20).

- This year we launched our inaugural Operation Proclamation, where we were able to arrange seven teams to visit sixteen nations of the fifty four African nations, to support the CRC outreaches, churches and the International Missions Bible College training and officiate graduations (to see some of the highlights go to www.facebook.com/ CRCMissionsInt.AUS). We look forward to making this an annual event each August as we see many new nations open to the CRC Movement. INTERNATIONAL MISSIONS

I am encouraged and invigorated for the future by what I see taking place in the ministry of the church of Jesus Christ. Yes, the world that we live in is "crazy", there is evil all around us and Gods people are exposed to fierce opposition and ridicule. But the kingdom of God is steadily advancing forward in the midst of such things and who knows if this might be our time to shine the brightest. I believe we can all feel positive and optimistic about the future advancement of the Gospel into people's lives and establishing the centrality of Christ in ALL things pertaining to living.

Let me share with you some good news stories of what has been taking place across the nations I am ministering to.

TRAINING

- There is a growing hunger by people to be trained and to grow in their knowledge of the scriptures. This is happening regardless of the fact that a number of nations are under duress and strong opposition religiously and internally with tribal unrest and serious conflict.
- In several Asian, African, and Pacific nations there are new training schools established, which is also encouraging to see. Some of them are National bases, while others are State, provincial or local-church based.
- For example, it is heartening to see increasing numbers of delegates growing every year at The CRC National Principals Conference in PNG - a definite and positive sign of new passion for coming together to dialogue, strategize and plan for a more coordinated effort in how to best prepare their people through training. There are initiatives to see new training schools restarted and new ones established in the whole nation.

- We are noticing an increasing number of female students enrolling for various types of training with the view of full time Christian service.
- This year is the largest intake of students in the Pre School-Teacher Training at Bethel PNG and all students are passionate about starting preschools in their own villages in different parts of PNG after graduation.
- The weekly participation of teachers from the Philippines, PNG, Fiji, Australia and USA lecturing into our training schools in other nations on set curriculum subjects through Zoom is exciting to see. It is strengthening the ties between our students and leaders in those nations and also expanding the opportunity for the teachers to experience ministry on a wider scale.

EVANGELISM

 The passion for engaging in evangelism is continuing in many nations. It is exciting to see the spontaneous nature of it - unstructured and managed but with a strong emphasis of personal one-to-one evangelism. Every week I am hearing of people being led to Christ on a daily basis and mostly from chance encounters, with many returning back to God.

MISSIONS

- There is also a growing interest in people entering missionary service and presenting themselves for training and preparation.
- b We are seeing increasing interest from both young and older people who wish to undertake short term mission trips. This includes families with children experiencing cross cultural lifestyles, seeing first-hand the complexities and challenges of these environments and social conditions that others

- face daily, comparing the living conditions with our own in the western world.
- There is a reviving interest from local churches and training schools in giving finance and resources to developing nations and global mission fields outside their own nation.

NEW CHURCH PLANTS

 This is steadily going on in many different places within the developing nations. This is not well known because of the poor communication facilities and also sensitive factors relating to some localities. But the desire to outreach and start penetrating unreached areas and people groups is continuing.

THE 52ND ANNIVERSARY OF CRC PNG

What a grand event the 52nd celebration of CRC in PNG was, with representation from all 22 provinces in PNG. Hundreds and into the thousands gathered to give thanks to God and proclaim their passion for evangelizing, church planting, training and global missions. It was a moving time to see the past and present PNG pioneers (pastors) publicly honoured and an overwhelming sense of all the CRC PNG family coming together as a movement. The presence of the Australian pastors and leaders including National and State chairpersons was a thrill for the PNG brethren. It was indeed a grand event and in the midst of it all, many tears taking place. A very moving event.

- and create a network of like-minded people wanting to serve in the nations.

Creating a pathway into missions with these 4 simple steps ...

Step 1

Missionary Connect Weekends and Online Training

Step 2

Missionary Training Intensives

Step 3

Missionary Exposure (1-3 Months)

Step 4

Further Training at World Missions Faith Training School (WMFTS in PNG) or Missionary Service.

This year Pathway to Missions has focused on the development of resources for youth and

young adults. The Papa Barry book is an amazing

resource for encouraging and inspiring people into mission both locally and internationally. To help with the use of this in group settings, we have developed two new resources to be used in conjunction with the book.

The first of these is "Pursuit", a youth-focused resource including 7 short videos telling the

Papa Barry story. Pursuit also includes a Leaders manual with additional resources and lesson plans. Pursuit is designed for youth small groups or discipleship groups. The second is a young adults study guide to be used in a small group setting in conjunction with Papa Barry.

Both these resources can be accessed online through the CRC Missions web site or via the REVYTH website.

In July 2024, the Pathway to Missions intensive was hosted at CFC Seaton. The 4-day school was deeply encouraging for all those who attended. Malachi Hammond (a young man from LeFevre CFC) has committed his gap year to missions' exposure in four different nations (Philippines, PNG, Uganda and India), spending about 6 weeks in each of these countries. Malachi will write up his story to encourage others to undertake a similar mission's exposure trip.

I am encouraged that Youth and Young Adults are wanting to engage with missions and it looks like we will have some more CRC missionaries heading off very soon.

It was a joy to launch our Strategic Directions 2023-2028 at last year's conference, where we set the new church planting goal for each one of us to plant or support a new CRC Church in the next 5 years. Imagine the potential if every existing CRC church and pastor contributed to church planting in some way – we would easily see twice the number of churches across Australia at a time when we seriously need a positive Christian influence in our communities and in our nation.

To help outwork this, we have a new National Church Planting team with representatives from each State. The team is led by myself and includes Andrew Cox and Sean LaBroy from Victoria, Trevor Murphy and Malcolm Taylor from NSW, and Joe Habermehl and Josh O'Callaghan from SA. What a power-house team!

In the last 12 months alone the following church plants have started: Reveal Church in North Clyde, VIC; Life Stream in Irymple, Mildura VIC; and TurningPoint Rosedale in VIC. Additionally a further two independent churches have affiliated with the CRC; Kingdom Impact Community Ministry in Sydney NSW, and Hope Assembly Church in Adelaide, SA.

Church Planting...

One of the important initiatives we are reviving is the Church Planting School Intensives, starting January 6-10 2025 at CFC Seaton. We ran these very successfully many years ago and saw many church planters emerge from this training, which is practical and inspiring. If you are interested or know someone who would benefit from this, you can access more details and register on the CRC website.

There are also some excellent church planting resources available. One organisation that has emerged in recent years to help resource church

planters is 'Exponential Australia'. We have already tapped into some of their training events and documentation and encourage you to check them out on their website.

Let's continue praying and believing together for opportunities to plant new churches and keep spreading the good news of the gospel across this great nation of ours.

CHRISTIAN SCHOOLS

Christian schools that are under the banner of CRC churches is a growing area of ministry and outreach in our movement. We have some outstanding church-school organisations that are at the forefront of the Christian school movement in Australia. Adelaide Christian Schools has nine schools and over 3000 students, leading the charge in the CRC. They have also planted a mission school in Port Moresby that is topping the national academic results. Other schools such as Portside Christian College in Adelaide and Lighthouse Christian College in Victoria are two strong schools that are having significant impact in their communities.

Under Pastor Phil Cayzer's leadership, Lighthouse Christian College has been a great instigator of new schools with churches outside the Turningpoint Church network. They have supported and help fund Verity Christian College in Griffith NSW and a new school in Redcliffs Victoria. They have modelled what we hope other CRC churches will follow in the future.

Just prior to Covid, Kingston City Church launched a second campus of Heatherton Christian College, now known as Christway College on the Wyndham City Church site. This new campus is experiencing steady growth and has passed Heatherton in student numbers.

This year, Sunnycliffs Lighthouse Christian College was launched out of Diggerland Church in cooperation with Lighthouse Christian College. It was a significant feat to get this school off the ground—the provision of God through the lease of a former school property was indicative of the grace of God on this venture. There have been challenges, but the hardest part of the process has been accomplished—starting!

Christian Schools...

Three other CRC churches have incorporated schools into their vision for the future. This is very important and exciting for our Strategic Directions for 2023-28 ... 'Each One can Plant One.' A new school can be planted as a school in its own right, which Church on Tarwin in Warragul is in the process of doing, or join with an existing school and launch as a campus.

We need to rise to the challenge of reaching and discipling our communities. Our nation is in need of Christ-centred education, which presents a world view that places God at the centre of human existence. As a movement we will do

what we can to support our churches that are maintaining a Christian ethos and purpose for their schools. Equally, we will support any of our churches in their endeavour to plant Christian schools in Australia or on the mission field.

Christian Education is a central element in reaching our nation for Christ. At the very least, it gives young people a knowledge of God, but more importantly it creates an opportunity for the revelation and the reality of the power of the Gospel to transform their lives.

We're excited about being able to promote training initiatives that are on offer within our movement and look forward to continuing to do so as we all commit to seeing 'Each One Teach One'.

 with practical and inspirational teaching,


connection and importantly equipping and training for our generations teams. Each State was well represented and we hope to build upon this strong foundation in the years to come.

<u>EVANGELISM</u>

"The greatest challenge today is to stimulate a significantly sized percentage of Christians to intentionally adopt "missional living" in their daily lives and relationships...We have to model and proclaim the Christian faith in our generation in a way that is both intelligible and compelling to our neighbours." - Timothy Keller, How to Reach The West Again

As we are acutely aware, Australian society (along with Western culture in general) has undergone some seismic shifts over the past 20 years. The shift to an increasingly secular culture has accelerated the rise of customised spirituality: "whatever works best for me". More and more, the shift in focus to "self" means individual identity expression is prized and "sexual freedom is considered one of the greatest goods of Western Society" (Sam Allberry, Why Does God Care Who I Sleep With?).

Phenomenal digital access means we are more connected than ever to what's happening globally yet there is an ever growing epidemic of loneliness. Our hearts break that many across Australia are growing up without any framework of understanding about the Christian faith, unaware that there is a Good Shepherd who laid down His life for us. We can no longer assume that the precious people we are called to love, serve and reach understand our need for a Saviour, why the Bible can be trusted, what the Good News of great joy for all people means for our lives today, and how to receive and trust in Jesus Christ, our Risen Lord.

While culture has changed ... wonderfully, the power of the gospel has not! Over the last year our National Evangelism Team (Roland Tankard -

VIC, Tim Coleman - SA Rural, Steve Rand - NSW; and myself - SA Urban) have been working together to identify key areas to equip 'Each One to Reach One'.

All of us can keep learning how to build relational bridges with the people around us, and listen more effectively and emphatically, like Jesus. Each of us can develop a better understanding of secular and other worldly viewpoints that many Aussies hold. We want to empower pastors and leaders in equipping people across CRC churches so they can respectfully critique culture through the lens of the gospel ... to see afresh its beauty, relevance and transforming power for our lives today.

There are some excellent books, reports, articles, relational evangelism training materials, sermon synopses and other resources available via our CRC website, to teach and train your local church in more effective missional living. In the coming months we will share stories of effective community engagement happening across CRC Australia, so we can encourage one another in the work of evangelism.

Importantly, we are inviting all our CRC churches across Australia to set aside a day of prayer and fasting on November 1, 2024. Let's pray audacious prayers for *Each One to Reach One*, and for the light of the gospel to shine in the hearts of individual people in our relational spheres and local communities, so that they too may come to know Jesus.



REPORT ON THE AUDIT OF THE FINANCIAL REPORT

Opinion

We have audited the financial report of CRC Churches International Australia Incorporated, CRC Missions International, and CRC Training (the association), which comprises the assets and liabilities statement as at 30 June 2024, the income and expenditure statement for the year then ended, and notes to the financial statements, including a summary of significant accounting policies, and the certification by members of the committee on the annual statements giving a true and fair view of the financial position and performance of the association.

Emphasis of Matter – Basis of Accounting

We draw attention to Note 1 to the financial report, which describes the basis of accounting. The financial report has been prepared to assist the association to meet the requirements of the South Australian Act. As a result, the financial report may not be suitable for another purpose. Our opinion is not modified in respect of this matter.

Responsibilities of the Committee for the Financial Report

The committee is responsible for the preparation and fair presentation of the financial report in accordance with the financial reporting requirements of the South Australian Act and for such internal control as the committee determines is necessary to enable the preparation and fair

presentation of a financial report that is free from material misstatement, whether due to fraud or error.

In preparing the financial report, the committee is responsible for assessing the association's ability to continue as a going concern, disclosing, as applicable, matters relating to going concern and using the going concern basis of accounting unless the committee either intends to liquidate the association or to cease operations, or has no realistic alternative but to do so.

Auditor's Responsibilities for the Audit of the Financial Report

Our objectives are to obtain reasonable assurance about whether the financial report as a whole is free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Notes to the Financial Statements For the Year Ended 30th June 2024

Note 1: Summary of Significant Accounting Policies

(a) Basis of Preparation

This special purpose financial report has been prepared for distribution to the members to fulfil the financial reporting requirements under the CRC Churches International Australia Inc constitution and the Australian Charities and Not-for Profits Commission Act 2012. The board has determined that the entity is not a reporting entity.

CRC Churches International Australia Inc is a not-for-profit entity for the purposes of preparing the financial statements.

The financial report, except for the cash flow information, has been prepared on an accruals basis and is based on the historical costs convention. The amounts presented in the financial statements have been rounded to the nearest dollar. The financial statements are presented in Australian dollars, which is the functional currency of the entity.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054: Australian Additional Disclosures.

(b) Income Tax

The entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

(c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

(d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

(e) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from donors and any outstanding grant receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.



Notes to the Financial Statements For the Year Ended 30th June 2024

(f) Employee Entitlements

Provision is made for the CRC Churches International Australia Inc's liability for employee entitlements arising from services rendered by employees to the end of the reporting year. Employee entitlements expected to be settled within one year, together with entitlements arising from wages & salaries and annual leave, which will be settled after one year, have been measured at their nominal amount. Other employee entitlements payable after one year have been measured at the present value of the estimated future cash flows to be made for those entitlements.

(g) Property, Plant and Equipment

Property, Plant and Equipment are brought to account at cost less, where applicable, any accumulated depreciation.

The carrying amount of Plant, Property and Equipment is reviewed annually by the Board to ensure it is not in excess of the future economic benefit of those assets. Individual items of plant and equipment in excess of \$500, which do not constitute a replacement, are capitalised.

Assets are depreciated on a diminishing value basis and the depreciation rates used for each class of depreciable asset are:

Furniture 10%-25%
Plant & Equipment 10%-25%
Computer Equipment 50%

(h) Reserves

Reserves for Future Conferences

Funds have been put aside for use towards the annual national conference, and have been preserved for that purpose.

Missions Resettlement Fund

CRC Missions receive funds which are specifically designated to certain missions. These funds are recorded as revenue when received by CRC Missions and are recorded as an expense when the funds are paid to their designated purpose.

Church Planting Funds Held

Funds that are received for church planting are recorded as income when received and as an expense when paid to their designated purpose. Any remaining funds are preserved until spent.

(i) Revenue Recognition

The entity recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefit will flow to the entity and specific criteria have been met for each activity as discussed below.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

All revenue is stated net of the amount of goods and services tax.

Donations

Donations are recognised as revenue when received.

Grants and Gifts

Minor grants and designated gifts are recognised as revenue when received.

(j) Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

(k) Financial Assets

Financial assets are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the association's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amoritsation process and when the financial asset is derecognised.


