### **EXECUTIVE REPORT**

This year commenced so well for me as I entered my **41st year** as Senior Minister of Christian Family Centre Churches. We began with the mother of all parties celebrating 40 years of leading the church and of married life to my faithful partner, Cathy. It was a great big Greek bash at the end of February with 300+ invited guests and what a moving and fun night it turned out to be. It culminated with traditional Greek dancing – and yes I even got up and did a dance or two!

I have travelled to PNG and the Solomon Islands, and believe it or not, to Sheffield England to watch a **snooker match** i.e. the two day final of the 17 days World Professional Snooker Championship. This was an unexpected gift from my gracious wife who, by the way, hates snooker. I now know that she really loves me.

In May at the annual Australian Pentecostal Ministers Fellowship (APMF), I was asked to chair once again this body that meets with heads of Pentecostal leaders over a 24 hour period each year. I've also ministered at two of our three State Conferences (I backslid attending VIC/TAS Conference for the snooker match in Sheffield).

All has been going well, but sadly I was diagnosed with cancer which required significant **surgery** in mid-August and this is why I cannot be at this year's National Conference – the first one I have missed in the 17 years I have been leading the CRC Churches International in Australia. This sickness battle is not good news, but neither is it a hopeless situation as my medical specialists are optimistic that they can deal with it. I trust Jesus and His wonderful promises that are so revelatory at this time. I'm expecting that through the presence and power of the Holy Spirit and the believing prayers of so many from across the world, I'm going to slay this giant.

This present conference for 2019, is a little like the historic 2003 "Imagine" Conference where we launched our first 5-year Strategic Plan and expanded Charter. Our conference theme is the CRC's catch cry "Creating Churches ... Changing Worlds", and it really does sum up the mission of the CRC here in Australia which is to exalt Jesus Christ in all we think, say and do and to extend His influence throughout the world.

We achieve our mission:

by proclaiming Christ's Gospel with the expectation that supernatural signs will follow as the normal New Testament pattern (Mark 16:15-20);

by planting Christ-Centred Churches that are autonomous, interdependent and self-propagating (Acts 14:21-28);

**by promoting Christ-glorifying Christian communities** which outwork the miraculous and character-transforming ministry of the Holy Spirit (Acts 2:42-47); and

by producing Christ following disciples who seek to obey the Great Commission and Great Commandment (Matthew 22:36-40; 28:18-20).

### NATIONAL CHAIRMAN...

It's my prayer that these three days together will **reinforce** our CRC beliefs, values and vision, and **reignite** our faith in Jesus to enable us to establish 500 churches here in Australia and have an ongoing ministry presence in every nation of the world by our centenary in 2045. All things are possible with Jesus (Matthew 19:26) as we practically outwork our faith in Him (James 2:17). Let's keep reminding ourselves He can do far above what we ask or imagine because of His limitless power that now indwells us (Ephesians 3:20).

There are a couple of important matters I have written to all our CRC Pastors and Churches about this year.

First the **National Redress Scheme**. As you are probably aware, the Federal Government scheme that all State and Territory governments, most Christian Denominations and Schools have signed up to stemmed from the Royal Commission into Institutional Child Abuse. Its aim is to financially support victims and help them find some closure without the combative and stressful legal processes of the court system.

The National Executive is recommending all our churches sign up to this National Redress Scheme through ACS Insurance or individually. It's a sad reality that historic sexual abuse cases in CRC Churches may be brought to our attention and the wisest course of action is for churches to be signed up to this compassionate and just scheme.

Second is the revised version of our CRC Statement of Faith. Let me give you some background to this.

Our CRC Statement of Faith framed in the late 70's and early 80's, has become a useful template for many CRC Churches. In the early 2000's when we revamped our CRC Charter, we summarised our Statement of Faith into a much smaller version but our official Statement of Faith hasn't been updated. Also in the early 2000's we asked Prs Ian Miller, Mark Walker and Dr Barry Chant, all whom have significant degrees in theology, to review our Statement of Faith. Unfortunately, at the time we got bogged down a little bit on the minor wording of some doctrinal points so we shelved it. We had other more spiritually important priorities, like setting in place a 5 year Strategic Plan which has now become normative for us as we prioritise our focus to reach our lost world.

It's my prayer that...this will reinforce our CRC beliefs, values and vision, and reignite our faith in Jesus to enable us to establish 500 churches here in Australia and have an ongoing ministry presence in every nation of the world by our centenary in 2045.

### NATIONAL CHAIRMAN...

The National Executive reviewed the work that Prs Ian, Mark and Barry did and felt that it was excellent and now, with some minor changes, are satisfied with the end result. The National Executive is presenting it to you for potential ratification in our October National Council meeting.

In this day and age where there is so much confusion, even in Evangelical-Pentecostal Churches, our Statement of Faith needs to be **tight as can be** in the most important areas and **a little looser** where there are genuine differences of theological perspective. We have tried to get the balance right for us as a Movement.

Facing major surgery and taking extended sick leave has reinforced to me the importance of having a top National Executive Team and a clear line of succession. Pr Bruce Sharman, our National Vice-Chairman, is a great man of God and a most capable leader who will be leading our National Pastors and Leaders Conference. Pr Bruce, who enjoys the confidence of our Pastors and Delegates, is also a dear friend, and along with our National Executive team will not miss a beat in relation to our Australian and worldwide denominational responsibilities.

The CRC in Australia is in good hands with Pr Trevor Murphy leading in NSW/QLD/ACT, and Pr Dan Parker doing an exemplary job in leading VIC/TAS over the past couple of years after Pr Bruce Sharman's long tenure in the role. I'm delighted to have Pr Joe Habermehl as the newly elected State Chairman of SA/NT/WA also on our National Executive team.

We also have Pr Chris Carmody and Pr Phil Cayzer, who champion Ministry Training, Church Planting and Christian Schools on the Movement's behalf. We have the very competent Peter Gillard as our National Administrator and the ever faithful Pr Nathan Bettcher has been reappointed as our new Executive Secretary and my Personal Assistant – it's a great team and I'm thankful to God for them as they selflessly and sacrificially serve the best interests of our great Movement.

I want to take this opportunity to commend Pr Hans Voortman who handed on the SA State leadership to Pr Joe after 22 years. Hans has also accepted our invitation to join the Australian International Missions Team (AIMT), the major sub-committee of the National Executive overseeing missions under the leadership of Pr Mike Cronin (our National Missions Director) and Pr Barry Silverback (our International Missions Director). I also want to commend Pr Ian Miller who recently handed on Community Church Hornsby after nearly 20 years of inspirational leadership. He has been a most loved and valued member of our National Executive team and we pray that his call to minister in the United States will be a blessed move and will greatly expand the Kingdom of God.

At last year's Effective Leaders/Effective Churches Conference, in accepting a nomination to serve for another 4 year term as your National Chairman I stated ... "I am committing myself to give you my best efforts and will not slow down in zeal for what Jesus wants to do through all of us who belong to the CRC in Australia and across the world." By the grace of Jesus I am believing that I can fulfil this commitment.

# NSW/ACT/QLD STATE REPORT

There are many positive aspects of life and ministry that bring great joy and a genuine sense of being where we're meant to be for a season, and one of these for me is the privilege of serving in my role as Chairman of our CRC Churches in NSW, ACT and Queensland.

### **EXECUTIVE TEAM**

Some years back I heard a wise leader describe three criteria for a team that is both effective in what it does and enjoyable to work with, these being character, competency and chemistry. I am so grateful for our State Executive team who model these attributes in everything they do. Heartfelt thanks to Pr Ian Miller who has served as Vice-Chairman on our team for a number of years and made a very significant contribution, not only within our State, but to the whole CRC family of churches. delighted to welcome Pr Geoff Hodgkinson from City Central Church in Albury, who has joined our State Executive team this year, and Pr Ralph Martin (Vice Chairman & Credentialing), Pr Rod Bortolin (Secretary), Pr Caroline Dennis (Children's Ministry) and Pr Francesca Liu have continued to serve for another term. Many thanks also to Jan Bollington (Treasurer/Admin support), Pr Jeff Cottom (Church Planting) and Pr Jodie Elliott (Youth) who very ably fulfil their portfolios and report to our State Executive team.

I'd really like to acknowledge and commend each of the local churches who release and support their Pastors and leaders in their State roles, including my own local church at Narrandera, who make no small contribution in serving the pastors and churches within the State and have done so for many years.

### **INCREASE & SUCCESSION**

In the past year we've seen three new church plants in Wollongong, Eastern and Western Sydney and 16 new credentials approved, being 2 National, 5 Affiliate State Ministers, 4 State Ministers and 5 Trainees. We've also seen 4 leadership successions successfully implemented at Colour City Church Orange, The Promise Centre Wagga Wagga, Community Church Hornsby and New Horizons Church St Mary's.

### **TRAINING**

Lifesource Church have been kindly hosting a group from the region completing CRC Certificate III studies this year and a few of our churches have continued to provide various levels of theological and leadership training in-house.

### **MISSIONS**

I know I mention it each year but a vast majority of our State churches and pastors are actively involved in overseas Missions endeavours at various levels, with many involved in, or supporting ministry in multiple nations. To me this is a very exciting indicator of the health and outward focus of our churches.

### **PASTORAL SUPPORT**

Our Regional Pastors Gatherings remain an important priority with the Sydney region, continuing strongly under the leadership of Pr Boo Teong Khoo, having met recently in Shellharbour. Our Southern Region is finding some new momentum this year with the most recent event seeing 25 pastors and leaders enjoying a great day in Narrandera. Most of our more remote pastors make a deliberate effort to stay connected or build relationship as best they can which is great to see.

A few years back we decided to schedule our State Executive meetings around various locations where we can meet with local church Pastors and leaders over a meal. Our March meeting took us to Canberra where over 20 regional pastors and leaders accepted our invitation for a very enjoyable and significant evening together and our September meeting was hosted in Condobolin which is still experiencing extreme drought conditions and all the challenges that come with that.

### **EVENTS**

Our State Pastors and Leaders retreat in Cooroy, QLD, was a great success and we're very much looking forward to hosting our very first State Conference in Narrandera on 22nd to 24th April, 2020 with Christa Smith from San Ramon, California as our guest speaker. Christa's husband Sean spoke at our State Conference a few years ago and we loved their heart and what they bought to us at that time.

Other regular events we facilitate as a State each year with considerable impact and fruitfulness are our Condo Youth Camp and our Emerging Leaders Gatherings, which all serve as exciting connection points for many of our youth and young adults. The ongoing success of these events gives us great encouragement as well as confidence and expectation for the future.

# SA/NT/WA STATE REPORT

I am so grateful to God and his servants for the blessing of our CRC family and excited to see the missions trips, training, discipleship, community care and great ministry of the Word and Spirit in every church. I hope you'll be fasting and praying with me for a harvest of salvations and the growing glory of Christ in more and more places locally and overseas.

# VIC/TAS STATE REPORT

The Victorian and Tasmanian churches are doing well. There is generally good health across the Movement; of course, there are challenges and areas of improvement, but there is unity of purpose.

Our focus is on creating healthy churches that are reaching and discipling the generations from children to young adults. This year, acknowledging the National Strategic Plan, we have embraced a young adults leader to bring energy to this area of church life. It's a major demographic in need of support—from this group will come future church planters and leaders.

The 'Implant' training days for children and youth leaders combined has been a slow burn to success. Every year the number of churches and

delegates grows, and the impact is significant. Equipping young people and ministers to be effective in ministry has led to some good growth in youth ministries across a range of churches. Pr Andrew Cox has led the youth team and has consistently focused on leadership development, which has precipitated healthy relationships and a unified group of leaders.

New initiatives in Church planting and rebirthing has resulted in new congregations. TurningPoint under the leadership of Pr Phil Cayzer has been very strong in this space and they would be the standout team that are breaking new ground.

A new school was launched by Kingston with a campus of Heatherton Christian College on the Wyndham site in the west of Melbourne. This is the fastest growing suburban area in the fastest growing city in Australia. Consequently, there is a massive need for schools and infrastructure. There have been financial, personal and planning challenges to overcome, but the payoff in witness and discipleship is worth the effort.

The Tasmanian scene is doing well. A number of churches have been through some difficulty, but they have seen stabilisation and growth. The Wynyard church which has its origins from Burnie has secured a church facility from the Brethren Church. It's an amazing answer to prayer, as the hall they were in was a very difficult proposition. The Hobart church is doing some good things in the community and has great access into Risdon Prison. The relationship with Victoria is developing well and we plan to hold our first State Conference in Launceston in 2021. We're working to have greater cross-connection in our generations training and support.

Training is going very well. A significant number of the students in the CRC college are from VIC/TAS churches. Internships is becoming increasing important to local church ministry development and we have seen a lift in the number of churches involved.


There is great scope for growth of numbers of churches and congregational size. We're excited about the future for our two most southern states.

## INTERNATIONAL MISSIONS REPORT

There are encouraging things that are taking place in global missions and ministry expressions of the CRC and its penetration into the nations. These past two years we can see a continued growth and steady advancement in the African continent, Asia, Canada, UK, the Pacific and Papua New Guinea.

### **TRAINING**

It is heartening to see the efforts being made to implement differing Biblical training opportunities for those in the nations. Increased opportunities for training exist in Africa, Papua New Guinea, Asia and the Pacific Islands. The preparing of people's lives through consistent exposure to the Word of God empowers and positions for service.



### PERSONAL EVANGELISM

Currently in some nations we are witnessing pockets where people are passionately and enthusiastically engaging in personal evangelism and sharing Christ with anyone. This is mainly taking place outside the walls of their churches on the streets and the marketplaces of the city or town.

### **PRAYER MADE**

There is a passion to be able pray for people for any reason and the expectation for the miraculous to result. The enthusiasm and youthfulness of these young men and women who are still in training is so heartening to see. New churches are being birthed as a result.

### RETURNING TO CORE VALUES OF THE CRC

Additionally, I am seeing a rising new vigor to return to the simple but practical core values of the CRC; of evangelism with the proclaiming of Jesus as the one who offers forgiveness of sins through his salvation. It is very promising that in more places we are seeing a return to the simple preaching of the Word of God and the Gospel of Christ.

### **FORGIVENESS OF SIN**

We are seeing that the message of the forgiveness of sins is being preached more frequently because of its prominence in those countries that I visit. I think that there seems to be more of an awareness of sin amongst people of these nations and they seem to be struggling with their own sin. Jesus Christ is the only one who freely offers forgiveness of sins **in this life** which is unique in its own right. Could this new awareness of sin and the need for forgiveness be something that God is doing; I think so? "When he comes, he will convict the world of guilt in regard to sin and righteousness and judgment: in regard to sin, because men do not believe in me." (John 16:8-9 NIV)

### I AM ENCOURAGED

I know that in the midst of all kinds of adverse and evil actions of man that GOD IS AT WORK. Yes, sometimes **unseen**, but He IS ALWAYS at work. Without a doubt God is at work **in the lives of men** and he is still saving, healing and delivering. God is at work in all the nations and discovering how and where is the adventurous part of serving him. Take heart in the truth that God IS at work and even when everything appears to be hopeless BELIEVE IN HOPE as did Abraham "Against all hope, Abraham in hope believed and so became the father of many nations, just as it had been said to him, 'So shall your offspring be.'" CRC Missions is continuing to make progress in the nations because of the faith and action of our pastors and churches. Thank you to everyone involved.

## INTERNATIONAL VISION – PRESENCE IN EVERY NATION BY 2045

Global mission continues to be a major aspect of the ministry of CRC Churches International. Great opportunities are opening up in Tanzania and East Africa to train pastors and open CRC Churches. Pr Phil Cayzer from Turningpoint Church, Cranbourne is leading this forward thrust. In 2018 – 2019 five Bible schools were established in Kenya with over 100 people graduating. The work in India is making very significant steps forward. Pr Mike Groom is continuing to work with Pr Warwick and

Omega Hughes to see the work in Walhalla, USA progress. Pr Mark Walker is investing significantly into Bolivia and northern Brazil where the leaders are keen to establish a missions training school. Opportunities continue to open up with ethnic groups in Australia as well as in another nations. The harvest is indeed plentiful. Pray that the Lord of the harvest will send out labourers into the harvest field. Then be ready to be the answer to your prayer. Go in his authority! (Matthew 9:37 – 10:1) Our international vision of a ministry presence in every nation by 2045 can be fulfilled.

### NATIONAL DAY OF PRAYER AND NATIONAL MISSIONS DAY

We continued this year in Australia and other nations with a National Day of Prayer Thursday (25th July) and a National Missions Sunday (28th July). This year the National Missions Day offering focused on the ISSP (International Students Sponsorship Program) which brings selected young leaders to Papua New Guinea for Training and Internship, thus equipping them for greater leadership in the future. Videos relating to this program were available on the Missions Website and a booklet was produced which was on the website and sent to pastors.

Many of the CRC Churches in other nations also joined this in 2019. What a powerful impact we will make in the Kingdom as all CRC Churches around the globe unite together in this.

The proposed dates for 2020 are National Day of Prayer Thursday 23rd July, National Missions Sunday 26th July.

Please get these dates in to your 2020 calendar.

### INTERNATIONAL LEADERS GATHERING

The International Leaders Gathering after our National Conference each year provides an excellent avenue for building relationships between all our National Leaders and the Australian pastors who are actively involved in Mission. Also the times of prayer and relationship building are essential for us to fulfil our International Vision. We focused in 2018 on the core values of CRC and what we are as a Movement. At the 2019 ILG there will be discussion relevant for the next 5 year International Strategic Directions to be released at our International Conference in October 2020.

### **COLOMBO PROJECT**

The Colombo project building is now providing an excellent facility for the CRC work in Sri Lanka. We are progressively repaying the loans to the SA/NT/WA and VIC/TAS State Councils. Thank you very much to every church which is contributing to this great project. However, there is still a shortfall in funds which will be needed to completely pay off these loans. If your church is not yet involved then I encourage you to contact the National Office for information about how to support this wonderful project.

### FINANCE

A Survey of Australian CRC Churches in July 2019 showed that Australian CRC churches gave \$1,765,614 to Global Missions in the year 2018 – 2019. This is 2% up on the previous year.

Missions giving through CRC Missions Office \$ 453,935 (26%)
Missions giving direct to CRC fields \$ 624,823 (35%)
Missions giving to Partner fields \$ 686,856 (39%)

The giving through CRC Missions office is very similar to the previous 2 years. The giving direct to CRC fields is up 10%, and the giving to partner fields is down 10% on the previous 2 years.

The ACNC have recently released increased accountability requirements for churches and mission organisation sending funds overseas. We are following the work of Missions Interlink to understand the implications of these new requirements to ensure that we comply with them. We will update churches as we have more details.

We deeply appreciate the extra 1% of tithes and offerings given to CRC Missions by our Australian CRC Churches to eradicate the consolidated debt that the mission account had been carrying for many years. This has now been completely paid out. Thank you very much to every church that contributed to this.

### A GREAT TEAM

Mikaela Groom has very effectively managed the CRC Missions Finance for the past year. She has done an outstanding job and has efficiently and effectively served our sponsoring churches as well as our various mission fields. Thank you very much Mikaela.

Mikaela Groom has also continued as editor of Pulse magazine. Thank you again Mikaela for the excellent job you do with Pulse in both your ideas and initiative as well as the actual production of the magazine. She has also started managing our CRC Missions website and Facebook page, as well as producing videos for promoting mission activities. We greatly appreciate her creative talents expressed in these forms of media.

The AIMT (Australian International Missions Team) consists of Prs Bill Vasilakis, Barry Silverback, Bruce Sharman, Neil Milne, Jeremy Steel, Norma Cayzer, Dave Manning, Ai Wari, and Mike Cronin (Chairman). In 2020 Pr Hans Voortman will also be joining the AIMT. Thank you to each member of the AIMT for your vision and commitment to missions.

# NATIONAL TRAINING REPORT

2019 has been another great year for CRC Training. The previous year saw the re-launch of vocational education through our Certificate III church-based VET ministry program, the continuation of AQF5 and AQF7 (Australian Qualifications Framework) Higher Education Diploma and Bachelor programs, as well as the expansion of our International Scholarship program.

Currently we offer a range of Higher Education programs through the Australian College of Ministries (ACOM) and the Sydney College of Divinity. These include Diploma of Ministry, Diploma of Christian Studies, Bachelor of Ministry and Bachelor of Theology. We also have several students undertaking post-graduate programs in Ministry. Our Vocational Education program (VET) is overseen by Vision College and CRC Training facilitates a number of audit and CRC recognised certifications.

We began the 2018/19 financial year with sixty Higher Education students. Of these, two have graduated. We currently have eighty Higher Education students (AQF5), which includes 61 students enrolled in the Diploma of Ministry (21 credential students, 7 mission students, 13 youth students, 14 worship students, 3 kids stream students; and 3 in general ministry). In addition, there are 19 students in our Bachelor cohort (17 Bachelor students and 2 post graduate students).

Student enrolments are spread across Australia and the world, with 54 students from Victoria, 15 students from South Australia, 7 students from New South Wales, 2 students from Queensland and 2 international students. Included in this are 2 audit students.

Our VET Certificate III in Christian Ministry and Theology (10432 NAT) was launched in Term 1 of 2019. We began with 62 students and currently we have seven churches involved with 39 students enrolled across Victoria, South Australia and New South Wales.

2017/18 saw the launch of our International Scholarship program. We currently have two international students, both from Poland, and another student undertaking the application process.

This year has proved to have been another very successful year, especially with our tri-annual camps and international study tours and mission trips. Our mission students went to The Philippines last year and ministered in a number of locations; our thanks to Pr Peter and Neila, Pr Robyn and Edna for hosting us so well and giving us the opportunity to minister in such a variety of locations, situations and churches. This year mission students will be ministering in Papua New Guinea in a new college plant.

In August we are excited to have the opportunity to partner with PNG to launch the Western Highlands School of Discipleship, an English-speaking Bible School in Mala, Western Highlands. We are also excited to be exploring the possibility of working with English-speaking churches in Prague in the Czech Republic. Our connection and involvement in Wroclaw, Poland is bearing fruit, with two international students on scholarship with CRCT, and next year CRCT is potentially becoming involved in Africa. Alongside our international plans, we are also excited to be planning an expansion of our Higher Education program for 2020, firstly by expanding our offerings to include counselling and education courses, and secondly, opening the way for significantly less expensive nationally-recognised accredited programs, and this alongside the much-anticipated launch of our unaccredited Online Education platform.

This is possible because we are blessed to have such an amazing, dedicated team and Movement. Our staff and students are located throughout Australia, as is our oversight. We are very thankful to our team, and for your continued prayers and support as we continue to equip more and more of our churches, students and staff to impact the world for Christ.

## CHURCH PLANTING REPORT

"I tell you ... I (Jesus) will build my church and the gates of Hades will not overcome it" (Matthew 16:18). These were the words spoken to the disciple Peter as the introduction to what the future ministry of the Kingdom of God to the world would look like. It was true then and still is the truth today; God's plan and intent has been to "through the church show His manifold wisdom" (Ephesians 3:10).

It has been my pleasure over the past few years to head the CRC Churches International Church Planting Team of Pr Sean La'Brooy (VIC/TAS), Pr Jeff Cottom (NSW/ACT/QLD and Pr Allen Steel (SA/NT/WA). Over this time we have seen new churches open and outreach services begin, all to bring about the Commission Jesus left us: "to go and make disciples of all nations..." (Matthew 28:19).

Over this past year the Church Planting Team has stepped up in offering themselves to any CRC churches that would like to have them come alongside any potential church planters or teams. As we see, the most successful church plants are those that start as a team and are sent out from a mother church. The Team would love to come and sit down and chat about things that they have seen work and those that have not worked, as well offer whatever support they can.

We have also continued to run our Church Planting Training via our annual TOOLSHEDs and Church Planting PD days that are held just before our National CRC Conference each year. These have seen continued support from within the CRC and more and more people are now attending. We want to thank the CRC National Executive for its dedication to supporting these events and supporting the potential church planters and their teams.

Church planting was at the heart of Jesus; it was at the heart of the CRC founder Pr Leo Harris, so it must continue to be in our heart. As we continue to see the CRC Churches International develop we must NEVER lose sight of the meaning of our CRC name "a group of Christians Crusading for Revival", and the only way to continue that revival is to have stable churches ready to do the work of discipling.

It is reported that new churches are **seven times more effective in bringing people to Salvation**, it is also reported that a new church has a **three times better retention of first-time commitments** to Jesus. So, to be more effective in seeing the Great Commission fulfilled we need to see new churches planted in every community group. Have you considered starting a second church service in a new area? Every church would have about 20% of the congregation willing to "have a go" at an afternoon or night service in a new location.

May we see great things together as we serve God together, and work towards our CRC goal of 500 Australian CRC churches by 2045.

# STRATEGIC DIRECTIONS REPORT

The Strategic Directions 2018-2023 for Australian CRC churches was approved at the National Council meeting in October 2018. We are now almost 12 months into this five-year period. Some highlights are noted in the paragraphs below.

### PASSIONATE EVANGELISM

In January this year the National office collected statistics for this area for the year 2018. It was reported that in CRC churches across Australia in last year;

- 866 people were converted to Christ
- 414 people were baptised in water
- 14,163 people visited one of our church services, and
- 28,166 people were touch by a CRC outreach ministry.

We hope to see a steady increase in these numbers over the next five years as churches and individuals engage with passionate evangelism. With Pr Ian Miller starting his ministry in the USA, the National Executive is looking at a new possible leaders or leaders for this area.

### **HOLY SPIRIT EMPOWERMENT**

In the same survey in January is was reported that during 2018 in CRC churches;

478 people were baptised in the Holy Spirit

Again, we hope to see a steady increase in this number, with a goal for having over 80% of church family members baptised in the Holy Spirit.

### UTILISING TECHNOLOGY

The new CRC website is nearing completion. Once this is up and running, then we can start to increase its effectiveness both in evangelism and information sharing across our Movement.

### REPRODUCING CHURCHES

The CRC in Australia has planted 25 new churches in the last 5 years, which represents 20% of the total number of CRC churches in Australia. Church planting will need to continue to be a priority if we are to reach our goal of 500 Australian CRC churches by 2045. To facilitate this planting process, Pr Phil Cayzer and his Church Planting team will be running Church Planting Training events around National and State conferences. Additionally, there will be a focus on church planting as a part of courses facilitated by CRC Training.

### **CONNECTING MINISTERS**

We regularly average around two-thirds of our credentialed CRC ministers in attendance at either our State and/or National gatherings each year, which is excellent and demonstrates the level of connectedness in our Movement. We also hope to strengthen our Regional Meetings to make these both regular and intentional in their focus of drawing our CRC ministers together for fellowship, support and prayer.

### **DEVELOPING CHURCHES**

Our National Chairman Pr Bill Vasilakis continues to meet annually with the Lead Pastors of 100+, 200+ and 400+ churches, with the view to develop leadership skills to grow their churches to the next level. Plans are also in place to have similar events with Lead Pastors of smaller churches, utilising the State gatherings where ministers are already meeting together to impart skills and ideas.

### STRATEGIC DIRECTIONS...

There has been an increased awareness and outworking of key governance policies and guidelines in churches over this last five years. It has been great to see over 20 of our churches join Safety Management Online as a CRC cohort to help better manage their Duty of Care process for Children and Youth. There will be some additional work for churches as they join up to the National Redress Scheme as recommended by the National Executive.

### SHAPING GENERATIONS

Pr Jodie Elliott has now been in the National Youth Director role for a year. Jodie has been working on a new CRC Youth website with means to increase the communication and social interaction of CRC Youth across Australia. She will also be leading the Youth Leaders Stream at the Pastors and Leaders Conference this year for the first time. In the January 2019 survey 47% of Australian CRC churches reported that they had an effective ministry and outreach to teenagers.

Pr Anna Nyhuis continues to lead the Children's area with vision and strength. Anna is looking at increasing her administrative support to better allow her to communicate with and support the Children's leaders in our churches across Australia. She will be leading her second Children's Leaders Stream at this year's National Conference. In the January 2019 survey 74% of Australian CRC churches reported that they had an effective ministry and outreach to children.

It has been great to have Pr Sieni Cayzer in place as our National Young Adults Director since late 2018. Sieni has visited State Conferences in Victoria and South Australia and is developing a network of Young Adults Leaders across Australia that she is relating to. In the January 2019 survey 32% of Australian CRC churches reported that they had an effective ministry and outreach to young adults.

### **REACHING NATIONS**

For more details on our CRC Missions strategies and outcomes, I refer you to the reports prepared by our International Missions Director, Pr Barry Silverback, and our National Missions Director, Pr Mike Cronin.

### TRAINING PEOPLE

For more details on our CRC Training strategies and outcomes, I refer you to the report prepared by our National Training Director, Pr Chris Carmody.

### CHRISTIAN EDUCATION

Pr Phil Cayzer is also championing this area. It is great to see an expanding network of CRC schools across our nation. At the end of 2018 we had over 4,500 students attending in CRC schools across Australia.

### CONCLUSION

I continue to enjoy my role in working with leaders across our nation as together we seek to further the cause of God's Kingdom, while at the same time keeping up with the very real and often insistent demands of administration and compliance.
