EXECUTIVE REPORT FROM PR BILL VASILAKIS NATIONAL CHAIRMAN

AN UPSIDE DOWN WORLD

What a tumultuous 12 months our Nation and the world has experienced. From massive bushfires that caused too many deaths, destroyed communities and burnt up our flora and fauna in the Eastern States and South Australia, to the horrific COVID-19 pandemic and now an economic recession that has followed in its wake.

This is the first time in our Nation's history that our Federal, State and Territory Governments have required a total shutdown of society. It has impacted the CRC and other Christian churches by not being able to meet as congregations, which is still being experienced in Victoria due to a second wave of this wretched virus that has decimated our vulnerable older citizens.

And on top of this, there has been terrible social unrest with rioting, looting and murders taking place in many American cities. This has supplanted the genuine peaceful protest movement that wants legitimate reform to the justice system in relation to policing practices and race matters. It has spilled over into the rest of the world, including Australia where there has been legitimate concern as to how our Indigenous peoples have been treated by our justice and correctional institutions, though thankfully the protests have been peaceful and non-violent.

A NEW JESUS REVOLUTION

With all that has taken place in 2020, it reminds me of the tumultuous period of the 1960's and particularly 1968. The Jesus Movement was birthed in the late 1960's / early 1970's with many hundreds of thousands of young people being swept into Jesus' kingdom across the western world. I was one of these teenagers. Millions of people were influenced by this amazing culture shifting youth movement and it impacted Jesus Church throughout the world, reverberating right up to our present time.

It seems to me that we are transitioning into a new era where a significant spiritual awakening will take place as the good news about Jesus is the only answer for a world that is becoming more and more morally confused and socially divided.

If there's a clear and resonating message for us, it is that we **prepare ourselves** as churches and ministries to **seize the opportunities** for evangelism with much greater fervency and to plant churches with strategic purpose.

In spite of the forced shutdowns throughout the year, the CRC has wisely utilised modern media platforms to continue feeding and leading the members of our churches. The online worship services being produced by our churches have been very good, considering we had no real notice of the various shutdowns. I had no idea what 'Zoom' was until a few months ago, and now we're using this technology to run leadership meetings, home groups and provide discipleship programs to our people. I'm rejoicing that CFC started a Zoom congregation with just 4 people during the shutdown in Darwin and they are now meeting each week with around 40 people — only God.

A HEALTHY MOVEMENT

The reports I have received from across Australia, is our CRC Churches have not missed a beat and in spite of severe restrictions like in Victoria, people are coming to Christ, being incorporated into churches and are being taught and trained in the way of Jesus. This speaks well of our CRC ethos that we are not just attracting crowds but building congregations and providing teaching that results in our people becoming strong disciples.

We have not been able to meet at State Conferences, but we are meeting for our **75th Anniversary Global Conference** and though most of the on-site delegates will be from South Australia, we are live streaming across Australia and the World so it could be our largest Conference ever.

We will be releasing our **International Strategic Directions 2020-2025** which gives broad coordinating strategies for the Nations where the CRC is organised and it provides a framework for them to develop their individual National plans.

I am also hopeful to release my latest book at Conference, called 'Revival is Our Middle Name'. This book is a collection of my Conference messages and reports as National Chairman since 2002, which documents our journey over the last 18 years as a movement.

Over the past 12 months we have added **6 new CRC churches** (either planted new churches or churches looking for a family like the CRC that have linked in with us), which is in line with our annual faith target.

At this year's Conference we are looking to our National Council to vote in some new younger National Executive members to join our team. I'm speaking of Pastors Tim Lochens, Jeremy Steel and Jodie Elliott (who will be a sit-in member).

Over the past 12 months I've been chairing the **APMF** (Australia Pentecostal Ministers Fellowship) and in our May gathering we had Martin Iles from the **ACL** (Australian Christian Lobby) share on the religious discrimination bill that is presently before Federal Parliament. I encourage all ministers to familiarise themselves with the details of this through the ACL website and wisely lobby their local Federal member to ensure a good outcome for religious freedom in Australia.

We also had Dr Ruth Powell from the **NCLS** (National Church Life Survey) share with us the importance of Pentecostal Churches in Australia continuing to be part of this unique 5 year survey. No other nation in the world has such a comprehensive church survey. It began in 1991 and I know our CFC Seaton church has not missed one, which has proved very beneficial to understanding the trends in society and how it affects our church.

We also had Dr Stephen Fogerty president of **Alpha Crucis College** which is now our RTO for ministry training courses. Alpha Crucis is the largest Christian College in Australia and in the coming years will become the first Pentecostal university in Australia. It is accountable to the ACC Churches movement which means its distinctive Pentecostal beliefs will never change. Please check out the CRC training options via our website, such as the Diploma courses that have now dropped in price significantly.

SOME BIG THANKYOUS!

I would like to acknowledge **Peter Gillard** who was our National Administrator for seven years and who received a call to return to teaching in a senior position at Portside Christian School (which is the education arm of Portlife Community Church). Peter is a dear friend who has given his heart and soul in the role so when you see him at Conference, please thank him personally. Peter is still assisting with the finances at present. I'm also thankful to Pastor David Bland who had been helping Peter with administration, who has also taken up full-time work overseeing school chaplains with the Schools Ministry Group (SMG).

Pastor Nathan Bettcher has returned to the role of National Administrator with assistance from Kassie Pidd who is employed 2 days a week to support Nathan and myself. Nathan is developing the office staff and we are supported by Brenda Giles who has recently retired as a top administrator in the Hospital sector and is volunteering her administrative skills in the CRC Office.

I would like to acknowledge **Pastor Anna Nyhuis** who has done a tremendous job as our National Children's Director. Anna has now finished up in this role and is assisting her husband Rob in his leadership role with the Churches of Christ.

I'd also like to thank **Pastor Bruce Sharman** as our Vice Chairman, the National Executive team, the Board of Elders at Christian Family Centre and my Senior Leadership Team at CFC Seaton. I am so appreciative for all of them, particularly as I faced a severe battle with illness for six of the past 12 months. My first lot of tests after surgery and radiation treatment have shown that I am cancer-free, but as all sufferers know this testing has to continue for the next several years. I am truly living out one of my favourite passages Philippians 4:4-7. I could write a book on every phrase of this magnificent scripture.

Rejoice in the Lord always. I will say it again: Rejoice! Let your gentleness be evident to all. The Lord is near. Do not be anxious about anything, but in every situation, by prayer and petition, with thanksgiving, present your requests to God. And the peace of God, which transcends all understanding, will guard your hearts and your minds in Christ Jesus.

Thank you for the letters of support and most importantly for your prayers as they helped me enormously to not just cope but overcome. I have come out of this dark valley more in love with Jesus and more appreciative of my church and denominational family. I am so appreciative of the fabulous people Jesus has placed around me who enable me to continue serving at CFC and the CRC.

May the Holy Spirit give you the grace, mercy and strength to step into the wonderful future Jesus has prepared for each of us. May our loving Heavenly Father be glorified in our lives and through our CRC family.



STATE REPORT FROM PR DAN PARKER VIC / TAS

The Churches in Victoria and Tasmania are generally in good health.

The relationship between States is developing well and will continue to evolve as we work together in the coming years. The next State Conference will be in Burnie and that will help bring greater connection.

The highlights for 2019-2020 have been in generations and training, which continues the trend of recent years.

The Youth and Children's ministry areas, through IMPLANT training days, are continuing to build. Thankfully, the Implant day was able to be held just prior to COVID-19 restrictions in March and we again saw an increase in attendance by young leaders. This year, for the first time we included Young Adults and we're hoping to build this area in the years ahead. Young Adult's (YA's) are an important initiative in our National Strategic Directions plan.

The other area that has been very solid is training, particularly in Victoria. About two thirds of the students in training nationally are from Vic/Tas, which is great for our future. There are some very good young leaders on the training-credential pathway and we expect to see new churches and ministries planted in the years ahead and the health of our existing churches continue to improve.

The challenge we face in the immediate future is to plant churches into new regions, towns and suburban areas. In Melbourne, the Northern and Eastern suburbs are ripe for new churches. There are opportunities for new schools also to be planted; it does require significant resources, however working with existing CRC churches with schools does open the possibility.

The three areas are linked to each other - Generations, Training and Church Planting are interconnected. As generations come through and receive good training and are mentored in competency skills and methods, they will be the next church and school planters.

How this plays out in a post-COVID-19 environment will be interesting to see, but what we do know is every Church will now have to adapt to a new paradigm. We will be looking at the new learning and passing it on to our Churches so we can grow and strengthen in our shared future.

NATIONAL DAY OF PRAYER AND NATIONAL MISSIONS DAY The 2020 National Day of Prayer (23rd July) and National Missions Sunday (26th July) were highly significant.

The dramatic global change with the COVID-19 pandemic has meant considerable change to overseas missions' involvement using Zoom and similar platforms for teaching, training and encouragement to our people in other countries. This has meant the need for good electronic equipment to communicate, hence the focus of the Missions Offering this year for electronic equipment to facilitate the internet communication. Videos relating to this were available on the Missions website and a booklet was produced which was on the website and sent to pastors.

Churches have responded very well and over \$23,000 has been received for assisting in getting this equipment. This is about twice as much in previous years for the Missions Offering and we greatly appreciate how churches have taken up to contribute to this great opportunity which is for now and for the future.

An increasing number of Churches in other nations are now joining in this annual event.

REPORT FROM PR BARRY SILVERBACK

INTERNATIONAL MISSIONS

Praise the Lord for His mercies endure forever.

Certainly, 2020 has been a challenging year with so many changes, restrictions of movement, loss of people's freedoms and the unexpected twists and turns that need to be managed and walked through, because of the global pandemic of COVID-19.

However, it has brought some encouraging positives in the lives of many believers as they have thrown themselves into prayer, fellowship and the reading and study of God's word. Also, there has been a greater sense of appreciation of each other and the strong sense of identification and camaraderie amongst themselves. It has also deepened and strengthened the resolve of many believers to go through this testing time with expectancy for that future time when it is over and the new normal arrives.

This has motivated many churches and individuals to acquire media equipment and the setting up of facilities in homes and offices with different forms of electronic communications, enabling us to stay connected with our national staff, workers, missionaries, students and congregations in those overseas nations. It was vital that we were able to counsel, encourage and direct those who have been seriously disadvantaged because of the lockdown and had severe restrictions imposed by COVID-19.

THE EFFECTS ON PERSONNEL FROM LONG PERIODS OF LOCKDOWN

There is a genuine concern about the effect on the lives of those that have been locked down for many months (some 7-8 months). I've been concerned for staff, workers, missionaries and congregations regarding their spiritual, emotional, mental and physical wellbeing.

I am aware that there are several churches and their congregations who are regularly communicating with their mission personnel and national leaders in places such as Africa,

Canada, Cambodia, Sudan, Europe and UK, Nepal, etc. helping them in different ways, relative to their respective circumstances that they are facing due to COVID-19.

This is very encouraging to see this happening on a broadening scale. Personally, I have also had to set up facilities (new and advanced Wi-Fi connection to the house) desk, camera, monitor, etc. so that I can communicate through several forms of electronic media with our missions ministry in some 9 different countries ably assisted by a team of missionaries and dedicated mission minded people who continue to use every effort to promote the cause of missions in the nations. We are currently hosting 9 regular daily zoom meetings every week into 4 different nations and additional live and recorded meetings in several additional nations.

These are teaching and mentoring style sessions with our Training School Staff, students and specific times with Pastors and national leaders, to hear their story, their struggles and victories and encourage and guide them through the uncertainties they are facing.

THE CHALLENGES OF COMMUNICATION

We as a team decided on using Zoom as our principal means of communication and using mobile phones, laptops and iPads for those who had them; but mostly smart phones. Initially we found it very difficult and disappointing due to the poor mobile connections, power blackouts and lack of access or funds to purchase data for their phones. This was very frustrating, but perseverance paid off in the end.

Here are some of the needy areas that we minister into:

- Addressing workers and missionaries in lockdown who cannot communicate with their parents or family regarding their safety from infection of COVID-19
- Helping staff through their grief as several of them have experienced death in their direct family (parents, sisters, children) and have been unable to attend burials, or even travel home to see their family
- To those personnel (workers, staff, students) facing loneliness, isolation, fear, frustration and uncertainty from the COVID-19 lockdown
- Encouraging and counselling overseas graduates from our training schools who are stranded in another nation or location and cannot return home
- For those missionaries who are currently stranded in overseas countries and have not been home for 3 & 4 years.

PROGRAM OF 'HOW TO TEACH TEACHERS'

Additionally, once every week for two hours we have been able to conduct "How to Teach the Teachers" lectures for our emerging teachers in our training schools and also some leaders pastoring churches in India. This is proving to be very effective and welcomed by the teachers.

WEEKLY CHAPELS AND COMMUNION SERVICES

This is where we invite different pastors and leaders from other countries (e.g. Philippines, Australia, New Zealand and PNG) to participate in (preach/conduct) these chapels (with communion) each week. We are currently planning to soon broaden the scope of persons who will participate.

LIVE SUNDAY SERVICES

We are also doing live zoom Sunday service into India, PNG and occasionally into New Zealand and the Philippines

It is a multi-faceted activity carried on by a great team of missions minded personnel.

Currently we are zooming with Nepal, India, Philippines. PNG, Sri Lanka, Bangladesh, Ghana, USA, Fiji, New Zealand and soon to start in Pakistan with a former Bethel student who is now pastoring a church and missions ministry.

God bless you in all your efforts for the continued proclamation of the Gospel of Jesus Christ everywhere.



REPORT FROM PR CHRIS CARMODY NATIONAL TRAINING

The last 12 months have been a great, rewarding, and challenging time for CRC Training (CRCT).

Currently we offer a range of Higher Education programs through our new partner organisation Alphacrucis College (AC). These include a Diploma of Ministry, Diploma of Leadership, Bachelor of Ministry and Bachelor of Theology, as well as direct study options with Alphacrucis College. Our vocational education program (VET) is overseen by Vision College and CRC Training facilitates a number of audit and CRC recognised certificates.

The CRCT Cohort current has 64 Higher Education students from 35 churches, including 3 non-CRC churches. We have students from across Australia with 42 from Victoria, 13 in South Australia and 6 from NSW; with the remainder being our international students. We are looking

to see the demographic of the College closer represent the CRC state demographics as we move into 2021 and beyond.

With the cancelation of all State Conferences, we did not have the opportunity to run our planned additional sessions or have an opportunity to engage with pastors about CRCT in the lead up to midyear intakes. Conferences are often the time where we make contact with new and interested students. Considering that this opportunity was not available we are extremely pleased to have 14 new students from around Australia commence with us midyear.

However, as National Conference is also varied this year. We are looking to partner closely with pastors and appreciate having them link their interested students with us. We have offered to do online visits, as our Relationship Managers have been unable to undertake face to face gatherings. We would love to see a greater uptake of virtual visits in the lead up to next year, as we hope to see our student numbers grow past previous levels as we move into 2021 and beyond.

REPORT FROM PR PHIL CAYZER CHURCH PLANTING

What a year 2019/20 has been! It has been the most unexpected time that any of us have seen in our lifetimes. I am reminded of the words the Apostle Paul, when he wrote to the Philippians, "Now I want you to know, that the circumstances have actually served to Advance the Gospel" (Philippians 1:12). What a statement! Considering he was writing from prison, to a church that started as a result of him being in prison, while in Philippi. Circumstances are not the indicator of the moving of God.

In 2019 there was an arising again of the pioneering spirit that has always been at the heart of the CRC Movement. We saw a number of new churches started and outreaches planned, as many of the CRC churches displayed a fresh desire and urgency to present the Gospel to impact new communities. In every State in Australia there was an excitement and vision to see new churches being established.

The CRC is a church planting movement. One of our many strengths is the creative and resourceful ways in which we have brought the Gospel to bear on people's lives. Church Planting is so often done in uncertain and evolving contexts. I remember the stories of our CRC founding fathers - they used whatever technology was available to get the Gospel out to the lost. They spoke on radio, printed magazines, created flyers and then started using TV. If they heard of a few people in an area coming to the Lord or

even a few people in an area ordering the "Revival" magazine, they would say, "We have the foundation for a new church plant," and they would activate this to see new churches started.

We have audited the accompanying financial statements of the Entity, which comprises the Balance Sheet as at 30 June 2020, the Income and Expenses Report for the year ended 30 June 2020, notes comprising a summary of significant accounting policies and other explanatory information, and the responsible Entity's declaration.

In our opinion, except for the possible effects of the matter described in the *Basis of Qualified Opinion* paragraph, the financial report of the Entity is prepared in accordance with Associations Act SA 1985, including:

a) giving a true and fair view of the registered Entity's financial position as at 30 June 2020 and of its financial performance for the year ended on that date.

BASIS OF QUALIFIED OPINION

Cash receipts are a significant source of fundraising revenue for the Entity. The Entity has determined that it is impracticable to establish control over the collection of cash receipts prior to entry into its financial records. Accordingly, as the evidence available to us regarding fundraising revenue from this source was limited, our audit procedures with respect to cash receipts had to be restricted to the amounts recorded in the financial records. We therefore are unable to express an opinion on whether the recorded cash receipts of the Entity are complete.

COMMITTEE'S RESPONSIBILITY FOR THE FINANCIAL REPORT

The committee is responsible for the preparation and fair presentation of the financial report that gives a true and fair view and in accordance with Australian Accounting Standards. Is appropriate to meet the requirements of the Associations Act SA 1985 and appropriate to

meet the needs of the members, and for such internal control as management determines is necessary to enable the preparation and fair presentation of financial report that is free from material misstatement, whether due to fraud or error.

We disclaim any assumption of responsibility for any reliance on this report or on the financial report to which it relates to any person other than the members, or for any purpose other than that for which it was prepared.

QUALIFIED OPINION

We have audited the accompanying financial statements of the Entity, which comprises the Balance Sheet as at 30 June 2020, the Income and Expenses Report for the year ended 30 June 2020, and a summary of significant accounting policies.

In our opinion, the Entity has complied, in all material respects with the compliance requirements as evaluated against the suitable criteria throughout the 1 July 2019 to 30 June 2020 period.
