#### NATIONAL CHAIRMAN REPORT

#### **Our Gracious Queen**

I write to you as we are still coming to grips with the death of Australia's Head of State, our dear Queen Elizabeth.

What a magnificent non-political, impartial and unifying monarch she has been for 70 years. Her sudden passing on to heaven has been a massive witness for our entire world. Over 4 billion people watched her funeral (the largest in human history), and how encouraging it was to hear of her personal faith in Jesus and public affirmation of Christ's lordship over her life. We have all grieved, but we are so grateful for the amazing example of her Christ-like selfless, servanthood. She exemplified the gospel in her life and it was boldly proclaimed through her death.

#### The Pandemic Challenge

Thankfully, we have seen the end of lockdowns and restrictions due to the deadly Covid 19 scourge.

There's been some heavy challenges as some of our churches have seen their attendances and finances drop and spiritual morale severely dented.

Pastors and leaders, we need to rise up to lead and feed our beautiful people with daring faith to counteract the anxiety and fear that has gripped so many. In these times we must prevail in prayer and boldly preach Jesus' Word,

especially the positive new creation message that is such an integral and distinctive part of our identity as a movement. Our people need a mighty infusion of faith, hope and love to neutralise the fears, doubts, worries and any spiritual declension that has crept into their hearts.

#### **Spiritual Health and Growth**

I'm rejoicing we have planted half a dozen new churches and some other churches have joined the CRC over the past year. It's thrilling to see pastors and churches stepping out in faith, assured that the Holy Spirit will always step in and provide for them, because they are outworking Jesus' Great Commission. This is what the CRC is all about - We preach Christ's good news, plant Christ centred churches and produce Christ following disciples who are empowered with an outreach-oriented mission's vision.

If you look at our overall statistics, we have around 140 Churches, whereas 10 years ago we were around 115.

Also, our overall numbers across the nation and our missions giving have been good, despite the troubling two years we all have experienced.

All the State Conferences I have attended have been really uplifting as pastors & leaders are hungry for meaningful connection and spiritual encouragement. I'm sure our LOVE PEOPLE National Conference will do the same.

#### **Wise Corporate Governance**

Pastor Wendy Brooks joined our national staff three days a week to help churches update and maintain the many governance regulations now required. Wendy did this for our SA/NT/WA churches last year and she was so appreciated and practically helpful, our National Executive has employed her to work with all our States and Territories around Australia. Wendy joined me at each of our State Conferences and she is visiting regions around Australia to explain how Pastors and Churches can implement the policy and procedure documents she has produced. The whole area of government requirements and regulations for all our churches is growing rapidly, so it's a gift to have someone like Wendy assisting in this quite complex area.

Pastor Nathan Bettcher will finish up as our National Administrator at the end of the year but will continue to be my Personal Assistant and Secretary for our National Executive. Nathan quickly stepped into this role after Peter Gillard was called back into high school teaching and was such a blessing when I faced my health crisis in 2019/2020 during some very trying seasons of convalescence. We all love Nathan dearly and I'm very thankful he volunteered

selflessly to help me and our movement over the last three years in an area that isn't his first love.

We are looking at transforming the Administration role to one of General Manager and are looking for someone with significant leadership/management skills to handle the expanding corporate dimension of our growing movement underpinning the Cause and Community dimensions of how we operate.

#### **Revive College**

Pastor Chris Carmody finished up leading the training department of our movement and I want to thank and honour him for his passion over many years to see people trained for Christian service. The Executive is prayerfully considering the appointment of a new training director and in the meantime, National Training Team members, Pastors Mark Walker and Jess Newman are operating as the interim leadership team.

REVIVE College is in good hands and has a most committed staff in Pastors Erin-Ruth Smith and Bill Lowrey.

As part of framing our next 5-year Strategic Directions (2023-2028), we will survey all CRC pastors and churches on our ministry training and leadership development strategies. The National Executive desire everybody to personally engage with this most important area, as its one of the key engine rooms for the future spiritual health and growth of our movement.

#### **Executive Leadership Positions**

I have been encouraged by the National Executive and other senior CRC Pastors to stand for a further 4-year term as National Chairman. I have been in this role since 2002 and do sense the Lord's guidance for me to continue giving my best leadership efforts as we prepare for our next 5-yr Strategic Directions (2023-2028).

My red-hot passion to facilitate revival growth in Australia has not dimmed but only increases as I pray over our very lost nation. Preaching the full gospel of Jesus, producing healthy fruitful churches, apostolic church planting, raising up new pastors/church planters/leaders and expanding our world missions' vision into the nations, continually fires up my soul.

I count it a wonderful privilege to serve the Movement in this way and I will give you my utmost and submit to the will of God through our National Council's decision.

Our long serving National Vice Chairman Pastor Bruce Sharman, will be relinquishing this role in favour of Pastor Danny Parker this term. Bruce is a wonderful minister and has been a huge personal support to me over the years. Bruce will remain on the National Executive as his vast experience is invaluable and is needed as we transition to a younger generation of leaders in the coming years.

Pastor Danny Parker, our Victoria State Chairman is a well-known, much loved and highly respected Lead Pastor of one of our largest and most fruitful churches. We have observed how he has handled his responsibilities as a State Chairman since 2017 following Pastor Bruce Sharman's long-term leadership in the State. I believe the best training for a new National Chairman is to lead a State for several years. Dan has excelled in this, and I know the CRC would be in good hands if anything should happen to affect my leadership.

The National Council resolved many years ago that the State Chairs should be elected members of the National Executive and therefore, Pastors Joe Habermehl (SA/WA/NT) and Trevor Murphy (NSW/QLD/ACT) will be nominated.

It is anticipated that Pastor Andrew Cox will become Victorian Chairman at our upcoming National Conference when the Victorian Council meets. He therefore will become a member of the National Executive and as a very experienced competent leader Andrew will add enormously to our team.

This frees up Pastor Danny to function as our new National Vice Chairman and work more closely with me.

I want to take the opportunity to honour the nominated Executive members for election. I witness how much they love their fellow CRC Pastors, serve to strengthen all our Churches and are fully committed to outworking our CRC Vision, Mission and Values.

Bruce Sharman, Philip Cayzer, Jeremy Steel and Jodi Elliott have been endorsed to continue in their current roles.

Chris Carmody as I mentioned earlier will not be continuing as he has finished up leading the training area.

Tim Lochens would like to step off the Executive to focus fully on his growing local church and young family now that a fourth child has come along. Tim is such a wise and honourable pastor that we reluctantly submitted to his heartfelt decision. We are keen that he re-engage in the future at a leadership level, as our movement needs the influence of brilliant character filled pastors like him to serve on our Executives.

#### **Challenge and Opportunity**

Our world is in such a mess. Hatreds divide communities, conflicts escalate where violence

becomes normative, and we have a sickening bloody war raging in Europe that could escalate with the use of nuclear weapons. Our nation of Australia is also experiencing some unusual insecurities, political and social divisions, religious scandals and a moral & ethical slide away from biblical/Christian values that is breathtaking.

This makes me more resolute and intentional to plant strong Bible based, Christ following, Holy Spirit empowered & People loving Churches across the country. Jesus' Church (His body here on earth), is the only hope for our needy world.

Our State Conference was held by Lifehouse Church in Murray Bridge last May. We were all so blessed by their hospitality and atmosphere of worship. #### **VIC & TAS STATE REPORT**

The Churches in Victoria and Tasmania have been rebuilding their face-to-face and public ministry throughout 2022. The Tasmanian churches were affected to a lesser degree through the COVID period, but still had the psychological effect on their people to deal with.

Victorian churches have been severely impacted by the physical and psychological isolation.

Reports from our Victorian pastors have been mixed. Some churches seemed to spring back to normal operations fairly quickly; while others are still experiencing the effects of people not responding or available like they were in the past. A few churches have been severely affected in their Sunday attendance numbers compared to the pre-COVID period.

There are some good news stories too—a few churches have grown. For example Wyndham City Church has experienced growth as people have been saved through connections with the school and others made decisions to go local in the Wyndham area.

In the Geelong region, Momentum Christian Church, Bannockburn became an autonomous congregation and independent of Waurn Ponds Community Church. The two leadership teams negotiated a smooth transition. Well done to all involved.

There have been some great new church initiatives.

Manningham sowed out a team to launch a service in

Clifton Hill—an inner suburb of Melbourne. Rosebud on

Mornington

Peninsula was launched as a Turning-Point church. In the west of Melbourne, the Grow Church team launched a church campus in Aintree. Wattle City Church in Maryborough have started services in the nearby town of Bealiba. Well done to our Senior Pastors and pioneering leaders for not being restrained by difficult circumstances.

A Karen (Burmese) church with three campuses and an outreach affiliated with CRC last year. Pastor David Tabu became connected through Roland Tankard, received an Affiliate credential and has brought his ministry and church planting under CRC. This has progressed through the year and David and his team are functioning well within the movement.

The State Conference in Colac was an excellent event. We had the highest number of delegates in recent memory attend the conference. There seemed to be a hunger among the pastors and leaders to be refreshed by the ministry and comradery of being together.

An important appointment was made in Portland. Steve and Brydie Green have taken on leadership of the church. Shane and Glenda Whitbourn handed over a very well positioned church—they have done a great job setting it up for success.

Swan Hill Community Church has come under the leadership of Diggerland. In consultation with the National Chair, it was decided by the State Executive to accept leadership of the congregation and they directed Diggerland to be the covering church in accordance with the SHCC and CRC Victorian Constitutions.

One of the difficulties of COVID has been the effect on youth and children's ministries across all denominations including CRC. Yet the Implant Training

## INTERNATIONAL MISSIONS REPORT

What a challenging 12 months that we have all been through, filled with such diversity uncertainty but also positivity. The sudden changes, impositions, the curbing of our normal freedoms, and the demands on our mental, moral, and emotions of our lives. It is difficult to know how people cope in these times without God being in their lives.

So regardless of what has taken place around us, our faith clearly and emphatically declares that God is still in control and is active throughout this world and that there are many wonderful, good news stories to be told of people coming to Christ, being baptized in water, empowered with the Holy Spirit, wonderful healings and new churches and home groups birthed.

Throughout these last 12 months I have witnessed amongst God's people a new ground swell of enthusiasm towards evangelism and preaching the gospel of all ages but especially of the younger generation We are seeing in several nations a definite resurgence of hunger to be trained and this is spanning all ages but especially the younger generation.

We are seeing spontaneous open preaching by small teams after a long absence in our cities and towns. Even in those nations where it is forbidden to bring people to Christ, or there is some form of repression, people are still finding ways to proclaim the Gospel. It is not just being present amongst them (presence evangelism) but proclamation evangelism, where the good news story is told, is articulated with words. God is at work, and people are still being forgiven, healed and delivered from demonic powers.

I'm constantly receiving stories and pictures from different countries of large numbers of believers going through the waters of baptism. There is a new push to send out new missionaries into the nations and I know of three missionaries from the third world that have been endorsed to take up positions in three different countries within the next 6 months.

Currently there is a significant amount of participation and interaction by third world leaders through regular weekly teaching. This is having a widening of their horizons and a strong bonding affect between the nations involved.

Pacific Islands and Asian churches are regularly giving of both finances and prayer to the developing nations. This is very encouraging to see. The temptation to slacken one's personal discipline because we are unable to change our circumstances, mental tiredness which eventually lowers personal performance erodes the will to continue.

The Devil constantly undermines the use of faith in the life of believers and the wearing down of their resolve to continue serving God. It's really a conflict between God's Word and the promotion of the ascendency of man's Wisdom. It's about the incessant questioning of God's existence and his relevancy in today's world and the demeaning of godly morals.

The National Missions Offering raised last year for new communication and recording equipment has greatly helped our training schools in the Philippines, India, Nepal, Ghana and PNG and other major center's where numbers of other local churches and leaders connect nationally for teaching / training, pastoral care, and regional gatherings. It has also provided equipment for Jeremy Steel and myself in our teaching and training sessions into the nations each week. A sincere thanks to everyone.

#### Our message is to:

"Hold on to the pattern of wholesome teaching you learned from me - a pattern shaped by the faith and love that you have in Christ Jesus". 2 Timothy 1:13 NLT

#### Our confession is:

That our God has not 'closed up shop' but continues to do everything according to his will among the host of heaven and among the inhabitants of the earth; and none can stay his hand or say to him, "What have you done?" Daniel 4:34-35 - Ephesians 1:11 ESV

#### **Some Praise Points**

- Papua New Guinea Bible Schools in several provinces have reopened this year and Bethel has managed to maintain a teaching program for the staff and some students throughout the past 12 months (2020-21).
- Recently there were 31 people baptized at Port Moresby Bethel Centre including 10 Indonesian refugees
- New Christian foundation class (new converts) established at Bethel Centre with 53 currently attending
- 5 new house fellowships started as a result of these new converts (reaching 49 people)
- Also 3 new churches started in the past 3 months in partnership with Bethel church in one the remote districts in the central province
- New churches birthed in several the provinces of PNG, Milne Bay, the Highlands, East New Britain, New Ireland, Bougainville, Gulf Provinces and some coastal regions.
- The Christian school at Bethel PNG has had some amazing awards throughout the past 12 months in spite of the pandemic and is considered as one of the top schools in the nation, and recently secured official authorization to move into secondary level education.

#### India

- In spite of the devastating COVID situation and the complete lockdowns in India we have been able to have two graduations of our two major training schools – (World Missions Training School) and the Evangelos International Training Institute and to have 11 of those graduates take up full time ministry with our CRC work spanning across our bases and schools in several different states.
- In June this year we able to re-open our training schools with a good number of new students and second year students.
- Also, one of our training schools was able to help fund and oversee the establishment of a new ministry base and church plant in a new state of India which is exciting to see.

#### Nepal

The Leadership Ministry Training School in the Eastern region of Nepal is continuing to train and develop pastors and leaders, and this is being funded and assisted by a local church here in Australia.

#### **Philippines**

The Philippines School of Ministry is also continuing to train and mentor young men and women from different provinces. Through its leadership its reaching out to several other provinces with current local training programs conducted through different electronic means.

Also, the local church in Manila has initiated with Bethel PNG a new trial training program of mentoring and developing full time trainees and staff of that church. There is a new Australian missionary couple that have been endorsed to go to the Philippines as soon as the nation's borders are open.

#### **Africa**

The many training schools / programs being monitored and assisted by local churches in Australia are continuing to function throughout the different African nations – including Ghana.

## International Vision – Presence in Every Nation by 2045

According to our last survey we were involved in a total of 76 nations (out of 195 in the world). Of these, 58 had a regular involvement contributing to an effective disciple making ministry. The remaining 18 nations only received an occasional investment. Ps Phil Cayzer has just invested 3 months in Africa, visiting 13 nations and strengthening the ministry of CRC in those nations, as well as expanding the involvement with CRC Missions Bible College.

## National Day of Prayer / Fasting & National Missions Day

This year the National Day of Prayer/Fasting was Thursday 28th July, and the National Missions Day was Sunday 31st July 2022.

The Mission Day offering this year was for equipment for the new Training Centre at Bethel Centre, Port Moresby PNG. At the time of writing this report we only have the offering from 8 churches amounting to \$20,195. There will no doubt be much more to come in so that we can have a well-equipped Training Centre in Port Moresby.

## PATHWAY TO MISSIONS REPORT

The purpose of Pathway to Missions is to encourage, train and prepare Australians for missionary service and create a network of like-minded people wanting to serve in the nations. We have created a pathway into missions with 4 simple steps ...

- Step 1 Weekend Seminars. (Run in each State)
- Step 2 One-week Missionary Training Intensive
- Step 3 Missionary Exposure (1-3 Months)
- Step 4 Further Training at World Missions Faith Training School (WMFTS PNG) or Missionary Service

This year we have been able run the Step 1 Weekend Seminar for Victoria, plus Step 2 Missionary Training Intensive at CFC Seaton. Both these programs were very successful, well attended and received positive feedback.

## Step 1 Weekend Seminar: Victoria – 23rd July 2022, Cranbourne Victoria

We had a great time with 42 people present, from 11 different churches from across Victoria. Norma Cayzer wrote "The day was informative, challenging, fun and full of fellowship ... appropriate for young and old. The sessions were honest, vulnerable, relevant and practical."

We finished the day with an amazing International Dinner provided by 6 of the cultural groups in the church at Cranbourne. The support of Norma Cayzer to run this event was greatly appreciated.

## Step 2 Missionary Training Intensive: South Australia 4th to 8th July 2022

The one-week intensive was attend by 12 full time delegates and one part time delegate. As this was a national event, 3 delegates flew in from NSW (which was very encouraging).

Pastor Barry Silverback, shared some amazing sessions from his life as a missionary. Other in-person teachers were Rachelle Hardy, Julie Fonarito, Vegena Bowering and myself. Added to this was the zoom sessions with Gwen Hageyo from the Philippines, Pastor Bill Vasilakis (who was in Darwin at the time), Norm Reed, Allen Steel, Sam Osborne and Danielle Rosslee. We also included time for reading and reflecting on the book "PAPA BARRY" (chapters 1-7), the delegates found this very helpful. I'm looking forward to running the one-week intensive again next year.

#### **Step 3 Missionary Exposure**

This year there has been one person take up 2 ½ months cross cultural missions/ministry exposure. Salome from Kingston City Church, spent her time in Alice Springs CFC working predominately with the Aboriginal ladies. During this time, she did a lot of pastoral visitation and Bible study, plus running the Sunday school each week. Salome was a great blessing to the work in Alice Springs. My desire is to see more people flow into doing cross culture missions exposure for 1-3 months, which can be tailored to the needs and availability of each individual.

# Training National

## NATIONAL TRAINING REPORT

We officially launched the College rebrand at National Conference last year and are now known as Revival College (www.revival.college). The rebranding process had been in progress for 18 months, with many elements of the college's function, culture and language being refined. This combined into our four operational values becoming everyday language within the college: those being Formation, Foundation, Connection and Commission.

The College had 40 Higher Education students during 2021, as well as one International Scholarship Student studying directly with Alpha Crucis (AC)

who is connected to Kingston City Church. The year 2021 saw 15 students engage nationally in the Introduction to Christian Studies course. In 2021 we had some 55 students on our books enrolled in various courses.

The Cohort has been smaller in 2022 with a total of 23 students comprising of eleven diploma, four bachelor, one international scholarship student; as well as seven in the vocational education program. During 2021 we saw the introduction of the Diploma of Chaplaincy and the continuing of our Diploma of Ministry, which is our most popular course.

Camp Two 2021 was held online via zoom as many cohort and staff members were in lock down restrictions limiting gatherings. Online camps allowed the College to have guests from interstate and overseas in a manner not always available for in-person gatherings, so that was an unseen benefit which compensated somewhat for not being in one venue. In March 2022

we were again able to gather face to face for our initial camp, without many COVID restrictions in place. In person gatherings are a wonderful opportunity for the cohort to meet not only other students who are studying but the college staff team. Again, we were joined by a range of CRC and external speakers who impacted and encouraged the cohort.

In 2022 we saw members of the team doing church visits, with students and alumni leading services across numerous Victorian churches; as well as a ministry-missions' trip to the Mildura and Broken Hill area. It has been a blessing to reconnect in person with our CRC family across numerous churches.

The biggest change to the College this year has been in our staffing. After 7 years as Principal, Chris Carmody has finished up in this role. We are very grateful to Chris for his leadership and initiatives throughout this season. We also farewelled Nick Johnson who has been an invaluable staff member and National Training Team member. Last but not least, Michelle Wallis has finished in her role with finances. Many thanks to Chris, Nick and Michelle.

As always, our team of staff and volunteers have shown incredible commitment to the students and the College, and will continue to do so. We all consider it an honour to serve the movement through the College. We are always thankful for your prayers and support as we continue to help pastors in equipping our churches and students to impact the world for Christ.

Jesus said, "... and the gates of Hades will not overpower the church."

Matthew 16:18

Jesus responds to Peter having the revelation that Jesus is the Messiah,

#### Notes to the Financial Statements

#### **Note 1: Summary of Significant Accounting Policies**

#### (a) Basis of Preparation

This special purpose financial report has been prepared for distribution to the members to fulfil the financial reporting requirements under the CRC Churches International Australia Inc constitution and the Australian Charities and Not-for Profits Commission Act 2012. The board has determined that the entity is not a reporting entity.

CRC Churches International Australia Inc is a not-for-profit entity for the purposes of preparing the financial statements.

The financial report, except for the cash flow information, has been prepared on an accruals basis and is based on the historical costs convention. The amounts presented in the financial statements have been rounded to the nearest dollar. The financial statements are presented in Australian dollars, which is the functional currency of the entity.

The financial statements have been prepared in accordance with the mandatory Australian Accounting Standards applicable to entities reporting under the Australian Charities and Not-for-profits Commission Act 2012, the basis of accounting specified by all Australian Accounting Standards and Interpretations, and the disclosure requirements of Accounting Standards AASB 101: Presentation of Financial Statements, AASB 107: Cash Flow Statements, AASB 108: Accounting Policies, Changes in Accounting Estimates and Errors and AASB 1054: Australian Additional Disclosures.

#### (b) Income Tax

The entity is exempt from income tax under Division 50 of the Income Tax Assessment Act 1997.

#### (c) Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances, the GST is recognised as part of the cost of acquisition of the asset or as part of an item of the expense. Receivables and payables in the statement of financial position are shown inclusive of GST.

Cash flows are presented on a gross basis. The GST components of cash flows arising from investing or financing activities which are recoverable from, or payable to, the ATO are presented as operating cash flows included in receipts from customers or payments to suppliers.

#### (d) Cash and Cash Equivalents

Cash and cash equivalents include cash on hand, deposits held at-call with banks, other short-term highly liquid investments with original maturities of three months or less, and bank overdrafts.

#### (e) Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from donors and any outstanding grant receipts. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

#### For the Year Ended 30th June 2022

#### (f) Employee Entitlements

Provision is made for the CRC Churches International Australia Inc's liability for employee entitlements arising from services rendered by employees to the end of the reporting year. Employee entitlements expected to be settled within one year, together with entitlements arising from wages & salaries and annual leave, which will be settled after one year, have been measured at their nominal amount. Other employee entitlements payable after one year have been measured at the present value of the estimated future cash flows to be made for those entitlements.

#### (g) Property, Plant and Equipment

Property, Plant and Equipment are brought to account at cost less, where applicable, any accumulated depreciation.

The carrying amount of Plant, Property and Equipment is reviewed annually by the Board to ensure it is not in excess of the future economic benefit of those assets. Individual items of plant and equipment in excess of \$500, which do not constitute a replacement, are capitalised.

Assets are depreciated on a diminishing value basis and the depreciation rates used for each class of depreciable asset are:

#### (h) Reserves

#### **Reserves for Future Conferences**

Funds have been put aside for use towards the annual national conference, and have been preserved for that purpose.

#### **Missions Resettlement Fund**

CRC Missions receive funds which are specifically designated to certain missions. These funds are recorded as revenue when received by CRC Missions and are recorded as an expense when the funds are paid to their designated purpose.

#### **Church Planting Funds Held**

Funds that are received for church planting are recorded as income when received and as an expense when paid to their designated purpose. Any remaining funds are preserved until spent.

#### **Notes to the Financial Statements**

#### For the Year Ended 30th June 2022

#### (i) Revenue Recognition

The entity recognises revenue when the amount of revenue can be reliably measured, it is probable that future economic benefit will flow to the entity and specific criteria have been met for each activity as discussed below.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed.

All revenue is stated net of the amount of goods and services tax.

#### **Donations**

Donations are recognised as revenue when received.

#### **Grants and Gifts**

Minor grants and designated gifts are recognised as revenue when received.

#### (j) Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period which remain unpaid. The balance is recognised as a current liability with the amount being normally paid within 30 days of recognition of the liability.

#### (k) Financial Assets

Financial assets are non-derivative financial assets that have fixed maturities and fixed or determinable payments, and it is the association's intention to hold these investments to maturity. They are subsequently measured at amortised cost. Gains or losses are recognised in profit or loss through the amoritsation process and when the financial asset is derecognised.
